

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

**Temporary Road Closure
Percy Road, Hampton****Temporary Suspension of Parking
Ashley Road, Station Approach and Milton Road, Hampton**

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate works on the level crossing in Percy Road they have made a temporary Traffic Order, the effect of which will be to introduce temporary prohibition of traffic in Percy Road, Hampton and suspension of parking places in Ashley Road, Station Approach and Milton Road, Hampton.
2. Whilst the works take place no person may permit a vehicle to proceed in Percy Road, Hampton between its junctions with Ashley Road and Station Road. These restrictions will apply at any time and when prescribed traffic signs are displayed.
3. The closure will come into force at 1am on Sunday, 3 November 2013 until 4am on Monday, 4 November 2013 and from 1am on Sunday, 24 November 2013 until 4am on Monday, 25 November 2013.
4. An alternative route for traffic will be via Ashley Road, Station Approach, Tudor Road and Station Road in both directions. Access to residents will be maintained.
5. Whilst the works take place no person may permit a vehicle to wait in:-
 - a. Ashley Road, Hampton the waiting restrictions will apply between its junctions with Percy Road and Milton Road or where relevant signs and cones are placed,
 - b. Station Approach, Hampton the waiting restrictions will apply between its junctions with Ashley Road and Tudor Road or where relevant signs and cones are placed; or
 - c. Milton Road, Hampton the waiting restrictions will apply between its junction with Ashley Road and the party wall of Nos. 72 and 74 Milton Road or where relevant signs and cones are placed.
6. The parking suspension will come into force at 9pm on Sunday, 3 November 2013 until 4am on Monday, 4 November 2013 and from 9pm on Sunday, 24 November 2013 until 4am on Monday, 25 November 2013
7. The order will remain in force for a period of 18 months, to allow for unexpected events and possible remedial works.
8. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.
9. Nothing in the Order applies to:
 - (a) any vehicle being used in connection with the execution of the said works or any public service or utility vehicle;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
 - (c) emergency service vehicles, subject to site conditions at the time of any emergency.
10. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.
