HEATH GARDENS, TWICKENHAM KEW GREEN, KEW LONDON ROAD, TWICKENHAM TALMA GARDENS, TWICKENHAM WHITTON ROAD, TWICKENHAM

(Reference 13/051)

- 1. The Council of the London Borough of Richmond upon Thames on 27 June 2013 made the above Orders under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Parking Places Amendment Order will be to remove an existing parking bay in Heath Gardens, Twickenham. It is located on the east side of the street and close to its junction with Heath Road. It currently has space for two cars for residents permit parking or pay and display parking (maximum stay 4 hours). The bay will be replaced with a single yellow line whose hours of operation will match the Central Twickenham controlled parking zone hours of between 8.30am and 6.30pm on Mondays to Saturdays.
- 3. The general effect of the **Waiting and Loading Restriction Amendment Order** will be to make the following alterations to parking restrictions:-
 - (a) London Road, Twickenham the east side replace a single yellow line (which indicates the Central Twickenham parking zone restrictions) with double yellow lines at the point where Katharine Road (a pedestrianised street) forms a junction with London Road (overall length being 12 metres):
 - (b) Kew Green at its junction with Bush Road, Kew introduce new double yellow lines at the junction of these two streets, for lengths of no more than 5 metres on any one arm of the junction;
 - (c) Whitton Road, Twickenham, in the vicinity of Chase Bridge and Talma Gardensreplace the single yellow line (which indicates the Rugby Zone parking restrictions) with double yellow lines ("no waiting at any time") on:
 - (i) the north side, for approximately 35 metres at the entrance to one of the RFU car parks; and
 - (ii) the south side, for approximately 20 metres on the eastern corner of the junction with Talma Gardens;
 - (d) Talma Gardens, at its junction with Whitton Road, replace the single yellow line with double yellow lines for distances of 10 metres (west side) and 12.5 metres (east side).
- 4. The Council has deferred making a decision in respect of the proposals to introduce similar restrictions in Mereway Road, notice of which was given on 19 April 2013.
- 5. Copies of the Orders, which will come into effect on Monday 15 July 2013, plans showing the location and effect of the orders and the Council's Statement of Reasons for proposing to make the Orders:-

- a. can be inspected, quoting Reference 13/51, at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and
- b. may be viewed on the Council's web-site at http://www.richmond.gov.uk/public_notices.htm
- 6. Copies of the Orders may be purchased from the Environment Directorate, Civic Centre, 44 York Street, Twickenham, Middx, TW1 3BZ.
- 7. Persons wishing to question the validity of the Order or any of its provisions on the grounds that it or they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Order was made, apply for the purpose to the High Court.

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Central Twickenham) (Parking Places) Order 2003(c), as amended, shall have effect as though:-
 - (a) the item which was added to Schedule 1A by the London Borough of Richmond upon Thames (Central Twickenham) (Parking Places) (Amendment No. 5) Order 2007 and which was given the item number 1A/2 by that order shall be renumbered as item 1A/7; and
 - (b) the item numbered 7A/15A in Schedule 7A to that Order as set out in columns 1, 2, 3, 4 and 5 of the Schedule to this Order shall be revoked.
