ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

Temporary Road Closure, Suspensions of Parking and of Oneway Working WAKEFIELD ROAD, RED LION STREET, LEWIS ROAD, CHURCH TERRACE, RICHMOND

(Ref: 13/092)

- 1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate essential utilities works they intend to make a temporary Traffic Order, the effect of which will be to introduce temporary prohibition of traffic in Wakefield Road and temporary suspension of parking bays in Red Lion Street and Lewis Street and a temporary suspension of one way working in Church Terrace and Lewis Road. Richmond.
- 2. Whilst the works take place no person may permit a vehicle to;
 - a. proceed in Wakefield Road Richmond from its junction with Church Terrace to its junction with Lewis Road; or
 - b. wait or stand in Wakefield Road or where relevant signs and/or cones are placed; or
 - c. wait or stand in Lewis Road or where relevant signs and/or cones are placed.
- 3. Whilst the works take place the one way working will be temporarily suspended;
 - a. in Church Terrace from its junction with Red Lion Street and its junction with Wakefield Road; and
 - b. in Lewis Road from its junction with Red Lion Street and its junction with Wakefield Road.
- 4. Whilst the works take place in Wakefield Street the parking bays in Red lion Street outside Nos. 14 to 26 will be temporarily suspended to allow for TFL buses to wait. Also three pay and display bays and a motorcycle bay will be suspended in Lewis Road to allow for the two way traffic to operate during the works
- 5. The order will come into effect on 19 August 2013. The works are anticipated to be in progress for a period of 2 weeks, i.e. until 2nd September 2013. The order will remain in force for a period of 18 months, to allow for unexpected events and possible remedial works.
- 6. The prohibitions will apply only during such time and to such extent as indicated by prescribed traffic signs.
- 7. Nothing in the Order will apply to:
 - (a) any vehicle being used in connection with the execution of the said works or any public service or utility vehicle;

- (b) anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
- (c) emergency service vehicles, subject to site conditions at the time of any emergency.
- 8. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.
