

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

**Temporary Footbridge Closure –  
Footbridge over Railway Track Linking Cole Park Road  
and Mary's Terrace, Twickenham**

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate bridge maintenance works they have made a temporary Traffic Order, the effect of which will be to introduce a footpath closure over Twickenham Footbridge linking Cole Park Road and Mary's Terrace.
2. Whilst the works take place no person may proceed in the footbridge linking Cole Park Road and Mary's Terrace, Twickenham.
3. Whilst the closure is in effect, an alternative route for pedestrians will be via Mary's Terrace, London Road and Cole Park Road,
4. The order will come into effect on 12 May 2014. The works are anticipated to be in progress from 12 May 2014 until 27 October 2014. The restrictions will generally be in force Mondays to Sundays inclusive at all times. The order will remain in force for a period of 6 months.
5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.

## TEMPORARY TRAFFIC MANAGEMENT ORDER

### THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY CLOSURE OF FOOTPATH) (TWICKENHAM FOOTBRIDGE) ORDER 2014

Made: 8 May 2014

Comes into operation: 12 May 2014

WHEREAS the Council of the London Borough of Richmond upon Thames being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network, are satisfied that pedestrian traffic should be prohibited along the footpath over Twickenham Footbridge linking Cole Park Road and Mary's Terrace in order to facilitate bridge maintenance works (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended by the Road Traffic (Temporary Restrictions) Act 1991(b) and by other enactments, and of all other enabling powers hereby make the following Order:-

#### Commencement and citation

1. This Order shall come into operation on 12 May 2014 and may be cited as the London Borough of Richmond upon Thames (Temporary Closure of Footpath) (Twickenham Footbridge) Order 2014 and shall remain in force for a period of 6 months.

#### Interpretation

2. (1) In this order, the following expressions shall have the meanings hereby assigned to each respectively:-

"The Council" means Council of the London Borough of Richmond upon Thames;

"enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) The Interpretation Act 1978(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

**Prohibition or restriction of pedestrian traffic**

3. (1) Whilst the works takes place no person shall be permitted to proceed over, or use the footbridge linking Cole Park Road and Mary's Terrace, Twickenham.
- (2) Nothing in paragraph (1) of this Article shall apply to any person engaged in the execution of the works or who may be visiting the works.
