

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 16A

**THE LONDON BOROUGH OF RICHMOND UPON THAMES (SPECIAL EVENTS) (MARBLE HILL  
HOUSE FESTIVAL) ORDER 2014**

**MONTPELIER ROW AND SANDYCOOMBE ROAD, TWICKENHAM**

(Reference 14/083)

1. The Council of the London Borough of Richmond upon Thames on 30 June 2014 made the above Order under section 16A of the Road Traffic Regulation Act 1984, as amended.
2. The general effect of this Order is to facilitate the holding of a festival in Marble Hill Park, Twickenham. The Order shall be in operation between 7am and 11.59pm on Thursday 3 July 2014.
3. Whilst the Order remains in force, no person may permit a vehicle to: proceed in
  - (a) Montpelier Row between its junction with Richmond Road and the end of the cul-de-sac,
  - (b) Sandycombe Road between its junction with Richmond Road and its junction with Norman Avenue.
4. An alternative route for vehicles affected by the closure of Sandycombe Road shall be available via adjacent streets and local access will be maintained whenever practicable.
5. The road closures will apply only during such time and to such extent as indicated by prescribed traffic signs.

## TEMPORARY TRAFFIC MANAGEMENT ORDER

### THE LONDON BOROUGH OF RICHMOND UPON THAMES (SPECIAL EVENTS) (MARBLE HILL HOUSE FESTIVAL) ORDER 2014

Made: 30 June 2014

Comes into operation: 3 July 2014

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the traffic authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads within the Royal Parks of Richmond Park and Bushy Park, (hereinafter referred to as "the borough roads") is satisfied that an event, the particulars of which are given in Article 2 of the following order, should be held on certain parts of the borough roads and that vehicular traffic should be prohibited and parking restricted in order to facilitate the holding of that event and to enable members of the public to watch that event.

NOW THEREFORE the Council in exercise of the powers conferred by Section 16A of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby makes the following Order:

#### Commencement and citation

1. This Order shall come into operation on 3 July 2014 and may be cited as the London Borough of Richmond upon Thames (Special Event) (Marble Hill House Festival) Order 2014 and shall remain in force for a maximum period of 1 day.

#### The Event and Interpretation

2. (1) The event for which this order makes provision is the Marble Hill House Festival.
- (2) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

"restricted hours" means between 7.00am and 11.59pm and these hours shall apply on the day of the event only.

#### Prohibition or restriction of vehicular traffic

3. During the restricted hours no person may permit a vehicle to: proceed in:
  - (a) Montpelier Row between its junction with Richmond Road and the end of the cul-de-sac;
  - (b) Sandycombe Road between its junction with Richmond Road and its junction with Norman Avenue.

4. Nothing in Article 3 of this order shall apply to any vehicle being used in connection with the said event or to any utility vehicle.
5. Nothing in this order shall apply:
  - (a) to anything done with the permission or at the direction of a police officer in uniform or traffic warden;
  - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion
6. The provisions of this order will only apply during such times when it is necessary or expedient to prohibit or restrict vehicular traffic in the road(s) or length of road(s) specified in Article 3 of this order and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002**(b)**, as amended.

**Alteration of position of/or removal of vehicles**

7. Where any vehicle is standing in contravention of the provisions of this order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.

**Contravention**

8. If a vehicle is left during the restricted hours without complying with the requirements of this order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004**(c)** may then be issued by a civil enforcement officer in accordance with the requirements of the said Act.

**Manner of payment of the penalty charge**

9. The penalty charge shall be paid to the Council as provided for by Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011**(d)**.
