LONDON BOROUGH OF RICHMOND UPON THAMES ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (2)(b)

Temporary waiting restrictions and temporary road closures Kew Road, Broomfield Road, Lichfield Road and Kew Gardens Road 16 to 20 July 2014

- 1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that because of the likelihood of danger to the public arising from events in the Royal Botanic Gardens, Kew known as "Kew the Music" they will introduce temporary waiting restrictions in Kew Road and Kew Gardens Road, Kew and temporary road closures in Broomfield Road and Lichfield Road, Kew.
- 2. Whilst the events take place no person may permit a vehicle:
 - (a) to wait on the east side of Kew Road from its junction with Kew Gardens Road to its junction with Stanmore Road: or
 - (b) to wait on the west side of Kew Road from a point 20 metres south of the southern kerb-line of Lichfield Road southwards for a distance of 60 metres which will be used as a drop off point for vehicles or from its junction with Queens Gate to its junction with Pagoda Avenue; or
 - (c) to wait on the north-east side of Kew Gardens Road from its junction with Princes Road to its junction with Cumberland Road; or
 - (d) to wait on the south-west side of Kew Gardens Road from outside No 23 Kew Gardens Road to its junction with Broomfield Road; or
 - (e) to enter or proceed in Lichfield Road; or
 - (f) to enter or proceed in Broomfield Road.
- 3. These measures will come into force between 6pm and midnight every day from 16 July to 20 July 2014, these dates being inclusive.
- 4. An alternative route for traffic affected by the closures is via Kew Gardens Road and Kew Road.
- 5. Nothing in this notice will apply to anything done with the permission or at the direction of a police officer in uniform, a traffic warden or an accredited steward.
- 6. The temporary measures described will be introduced by this notice given under Section 14(2)(b) of the Road Traffic Regulation Act 1984, as amended. The notice will come into effect on 16 July 2014 and will remain in force until 20 July 2014.
- 7. The prohibitions will apply only during such time and to such extent as indicated by prescribed traffic signs and/or cones.
- 8. Any vehicle waiting in contravention of any restriction imposed by this notice may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.
