ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

Temporary Footpath Closure Vineyard Passage, Paradise Road, Richmond

(Reference 14/093)

- 1. The Council of the London Borough of Richmond upon Thames on 31 July 2014, made a Temporary Traffic Order cited as the London Borough of Richmond upon Thames (Temporary Closure of Footpath) (Vineyard Passage, Richmond) Order 2014 in order to facilitate construction of a hotel. The Order came into force on 4 August 2014 for a period of six months.
- 2. The Secretary of State for Transport has approved the continuing in force of the abovementioned Order until 3 February 2016, or until such time as the works are completed, whichever is the sooner.
- 3. At such times that the provisions of the Order are in force no person may proceed in Vineyard Passage between Paradise Road and Halford Road.
- 4. Whilst the closure is in effect, an alternative route for pedestrians will be via Halford Road and Paradise Road.
- 5. The order came into effect on 4 August 2014 and the works are expected to take up to 13 months to complete from that date. The provisions of the order will be in force only at such times when absolutely necessary and where relevant signs are placed. The order will remain in force until 3 February 2016 or until the works are competed, whichever is the sooner.
- 6. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.



- 1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate construction of a new hotel they have made a temporary Traffic Order, the effect of which is to introduce a footpath closure in Vineyard Passage, Richmond.
- 2. At such times that the provisions of the Order are in force no person may proceed in Vineyard Passage between Paradise Road and Halford Road.
- 3. Whilst the closure is in effect, an alternative route for pedestrians will be via Halford Road and Paradise Road.
- 4. The order will come into effect on 4 August 2014. The works are anticipated to be in progress from 4 August 2014 and take up to 13 months to complete. The provisions of the order will be in force only at such times when absolutely necessary and where relevant signs are placed. The order will remain in force for a period of 6 months, after which time the Council will seek approval to continue in force the provisions of the Order for a further 6 months.
- 5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY CLOSURE OF FOOTPATH) (VINEYARD PASSAGE, RICHMOND) ORDER 2014

Made: 31 July 2014

Comes into operation: 4 August 2014

WHEREAS the Council of the London Borough of Richmond upon Thames being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network, are satisfied that pedestrian traffic should be prohibited along the footpath known as Vineyard Passage linking Paradise Road and Halford Road in order to facilitate hotel construction works (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended by the Road Traffic (Temporary Restrictions) Act 1991(b) and by other enactments, and of all other enabling powers hereby make the following Order:-

Commencement and citation

 This Order shall come into operation on 4 August 2014 and may be cited as the London Borough of Richmond upon Thames (Temporary Closure of Footpath) (Vineyard Passage, Richmond) Order 2014 and shall remain in force for a period of 6 months.

Interpretation

2. (1) In this order, the following expressions shall have the meanings hereby assigned to each respectively:-

"The Council" means Council of the London Borough of Richmond upon Thames;

"enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) The Interpretation Act 1978(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Prohibition or restriction of pedestrian traffic

- 3. (1) Whilst the works takes place no person shall be permitted to proceed in Vineyard Passage, Richmond between Paradise Road and Halfrod Road.
 - (2) Nothing in paragraph (1) of this Article shall apply to any person engaged in the execution of the works or who may be visiting the works.
