CLIFDEN CENTRE, TWICKENHAM CAR PARK**

1. The Council of the London Borough of Richmond upon Thames on the 11 September 2014 made the above Order under section 32 of, the Road Traffic Regulation Act 1984, as amended.
2. The effect of the Order is that due to the closure of the car park at the Richmond Adult and Community College, Clifden Centre, which is located adjacent to Clifden Road, Twickenham, the London Borough of Richmond upon Thames (Off-Street Parking Places) (Civil Enforcement) (Amendment No. 2) Order 2012 is revoked.
3. Copies of the Order, which will come into operation on 1 October 2014, a plan showing the location of the car park and the Council's Statement of Reasons for making the Order:-
 - (a) can be inspected for a period of six weeks from the date of this Notice, quoting Reference 14/119, at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and

5. Persons wishing to question the validity of this Order or any of its provisions on the grounds that it or they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Order was made, apply for the purpose to the High Court.

1. This Order shall come into operation on 17 September 2012 and may be cited as the London Borough of Richmond upon Thames (Off-Street Parking Places) (Civil Enforcement) (Amendment No. 2) (Revocation) Order 2014.
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Off-Street Parking Places) (Civil Enforcement) (Amendment No. 2) Order 2012 is hereby revoked.

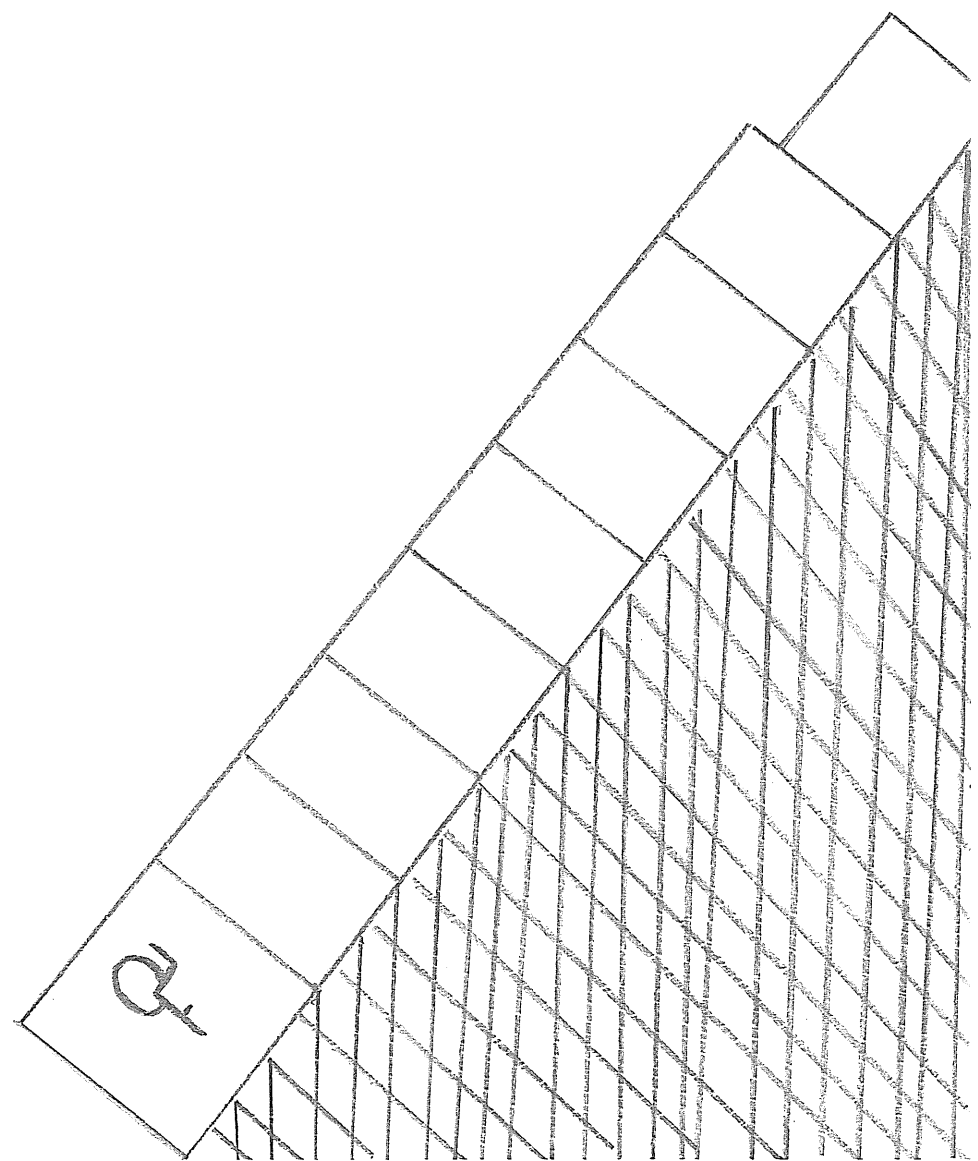
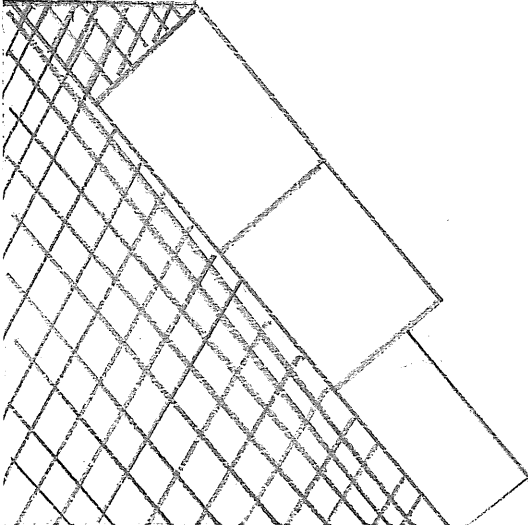
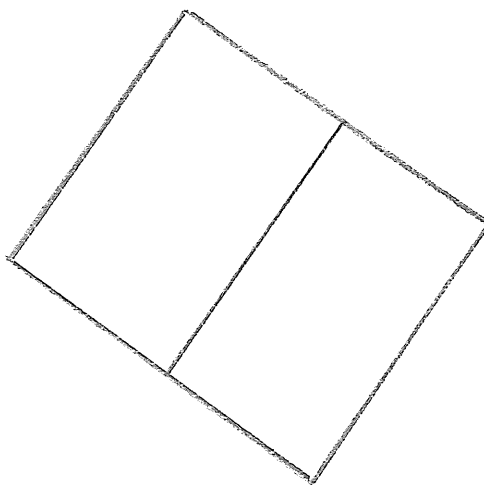
STATEMENT OF REASONS
