

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 16A

**THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY
PROHIBITION OF TRAFFIC) (SPECIAL EVENTS) (CABBAGE PATCH 10 RUN) ORDER
2014**

RICHMOND ROAD AND LEBANON PARK, TWICKENHAM

(Reference 14/133)

1. The Council of the London Borough of Richmond upon Thames hereby gives notice that on 14 October 2014 they made the above named Order under Section 16A of the Road Traffic Regulation Act 1984, as amended.
2. The purpose of the Order is to allow for the Cabbage Patch 10 Run event to take place on the public highway. The event will take place on Sunday 19 October 2014 at the times specified in paragraph 3 below.
3. Whilst the event is taking place:-
 - (a) no person may permit any vehicle to enter Lebanon Park at its junction with Richmond Road;
 - (b) no person may permit any vehicle to enter Sion Road at its junction with Richmond Road;
 - (c) no person may permit any vehicle, including buses, to proceed in the bus lane in Richmond Road, Twickenham on the south-east side, from a point 16 metres north-east of the north-eastern kerb-line of Lebanon Park, Twickenham to a point 12 metres south-west of the north-eastern kerb-line of the access road leading to the York House municipal offices;
 - (d) the provisions of the London Borough of Richmond upon Thames (The Riverside, Twickenham) (Closure) Order 2000 shall be suspended.
4. Nothing in this Order will apply to:
 - (a) anything done with the permission or at the direction of a Police Constable or a Civil Enforcement Officer.
 - (b) any vehicle being used by a statutory undertaker, whereby it is necessary by reason of an emergency, for that vehicle to have access to part of the street under restriction.
5. The prohibitions or restrictions specified in this notice will apply only during such times and to such extent as indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002.
6. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY RESTRICTION OF TRAFFIC) (SPECIAL EVENTS) (CABBAGE PATCH 10 RUN) ORDER 2014

Made: 14 October 2014

Comes into operation: 19 October 2014

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the traffic authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads within the Royal Parks of Richmond Park and Bushy Park, (hereinafter referred to as "the borough roads") is satisfied that an event, the particulars of which are given in Article 2 of the following order, should be held on certain of the borough roads and that vehicular traffic should be prohibited and parking restricted in order to facilitate the holding of that event and to enable members of the public to watch that event:

NOW THEREFORE the Council in exercise of the powers given under section 16A of the Road Traffic Regulation Act 1984(a) as amended and of all other enabling powers hereby makes the following Order —

Commencement and citation

1. This Order shall come into operation on 19 October 2014 and may be cited as the London Borough of Richmond upon Thames (Temporary Prohibition of Traffic) (Special Events) (Cabbage Patch 10 Run) Order 2014 and shall remain in force for one day.

Interpretation

2. (1) The provisions of this order will facilitate the holding of the Cabbage Patch 10 Run;
(2) In this order, the following expressions shall have the meanings hereinafter assigned —

"restricted hours" means the hours between 10am and 1pm;

"specified day" means the 19 October 2014;

"police community support officer" means a person who has been so designated by the Metropolitan Police Service as provided for by Section 38 of the Police Reform Act 2002(b), and

"accredited person" means a person who has been accredited by the Metropolitan Police Service under the Community Safety Accreditation Scheme as provided for by Section 41 of that Act;

and in either case whilst exercising the powers of a police community support officer or an accredited person that person is wearing an approved uniform as provided for by Section 42(2) of that Act.

- (3) The Interpretation Act 1978(c) shall apply for the interpretation of this order as it applies to the interpretation of an Act of Parliament.

Prohibition or restriction of vehicular traffic

3. During the restricted hours on the specified day:-
- (a) no person may permit any vehicle to enter Lebanon Park at its junction with Richmond Road;
 - (b) no person may permit any vehicle to enter Sion Road at its junction with Richmond Road;
 - (c) no person may permit any vehicle, including buses, to proceed in the bus lane in Richmond Road, Twickenham on the south-east side, from a point 16 metres north-east of the north-eastern kerb-line of Lebanon Park, Twickenham to a point 12 metres south-west of the north-eastern kerb-line of the access road leading to the York House municipal offices;
 - (d) the provisions of the London Borough of Richmond upon Thames (The Riverside, Twickenham) (Closure) Order 2000(d) shall be suspended.
4. Nothing in Article 3 of this Order shall apply to any vehicle being used in connection with the said event or to any public service or utility vehicle.
5. Nothing in this Order shall apply:
- (a) to anything done with the permission or at the direction of a police officer in uniform, traffic warden, police community support officer or an accredited person.; or
 - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion.
6. The provisions of this Order will only apply during such times when it is necessary to prohibit or restrict vehicular traffic in the road(s) or length of road(s) specified in Article 3 of this order and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002(e), as amended.

Contravention

7. If a vehicle is left during the restricted hours without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004(f) may then be issued by a civil enforcement officer in accordance with the requirements of the said Act.

Alteration of position or removal of vehicles

8. Where any vehicle is standing in contravention of the provisions of this Order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.

Manner of payment of the penalty charge

9. The penalty charge shall be paid to the Council as provided for by Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011(g).
