Temporary Waiting Restriction Waldegrave Park, Twickenham

(Reference 15/019)

- 1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate building works to be undertaken at Newland House School, they have made a temporary Traffic Order, the effect of which is to introduce a temporary prohibition of traffic in Waldegrave Park, Twickenham.
- 2. Whilst the works take place, no person may permit a vehicle to wait or stand in
 - Waldegrave Park, on its northern side, from a point 25 metres west of the eastern boundary of No 21 Waldegrave Park, westwards for a distance of 24.5 metres;
 - (b) Waldegrave Park, on its southern side, from a point 5.5 metres east of the eastern boundary of No. 28 Waldegrave Park, westwards for a distance of 32 metres.
- 3. The order will come into effect on 20 April 2015. The works are anticipated to be in progress from 20 April 2015 until 30 June 2016. The provisions of the Order will be in force on Mondays to Fridays between 7.30am and 6pm. The order will remain in force for a period of 18 months, to allow for unexpected events and possible remedial works.
- 4. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.
- 5. Nothing in the Order applies to:
 - (a) any vehicle being used in connection with the execution of the said works or any public service or utility vehicle;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
 - (c) emergency service vehicles, subject to site conditions at the time of any emergency.
- 6. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY PROHIBITION OF TRAFFIC) (VARIOUS STREETS, ELECTION FACILITATION) ORDER 2015

Made: 30 April 2015

Comes into operation: 5 May 2015

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted in order to facilitate delivery and collection of accommodation for the holding of an election (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order:-

Commencement and citation

1. This Order shall come into operation on 5 May 2015 and may be cited as the London Borough of Richmond upon Thames (Temporary Prohibition of Traffic) (Various Streets, Election Facilitation) Order 2015 and shall remain in force for a maximum period of 18 months. Details of the dates and times that the Order will be in force are given in the Schedule to the Order.

Prohibition or restriction of vehicular traffic

- 2. Whilst the works take place no person may permit a vehicle to wait or stand in a length of street described in column 2 to the Schedule to this Order on the dates and times detailed in column 3 to the Schedule to this Order.
- 3. Nothing in Article 2 of this Order shall apply to any vehicle connected with the execution of the said works or to any public service or utility vehicle.
- 4. Nothing in this Order shall apply:-
 - (a) to anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
 - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion, provided that conditions which prevail on site at any one time do not render it unsafe or impossible for such a vehicle or vehicles to use any part of the public highway for the time being.

5. The provisions of this Order will only apply during such times when it is necessary to prohibit or restrict vehicular traffic in that road or length of road and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002(**b**).

Contravention

6. If a vehicle is left during the restricted time without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004(c) may then be issued by a civil enforcement officer in accordance with the requirements of that Act.

Manner of payment of the penalty charge

7. The penalty charge shall be paid to the Council as set out in Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011(d).

Alteration of position or removal of vehicles

8. Where any vehicle is standing in contravention of the provisions of this Order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may, under the provisions of the Removal and Disposal of Vehicles Regulations 1986(e), as amended, remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.

1.	Edgar Road, Whitton – both sides, from a point outside the common boundary of Nos. 141 and 143 Edgar Road to a point outside the common boundary of Nos. 74 and 76 Edgar Road.	Between 6am and 11am on 6 May 2015 and between 6am and 11am on 8 May 2015.
2.	Edgar Road and Simpson Road, Whitton - both sides, from a point outside the south-eastern boundary of Slade House, to a point in Simpson Road, 15 metres south-east of its junction with Edgar Road.	Between 6am and 11am on 6 May 2015 and between 6am and 11am on 8 May 2015.
3.	Bicester Road, Richmond (north to south arm) – both sides, from its junction with Somerton Avenue and Bicester Road (east to west arm), southwards to a point outside the southern boundary of No 1 Bicester Road.	Between 9am and 3pm on 5 May 2015 and between 9am and 3pm on 8 May 2015.
4.	Lambert Avenue, Richmond - both sides, from a point outside the southern boundary of No. 1 Bicester Road to the end of the cul-de-sac.	Between 9am and 3pm on 5 May 2015 and between 9am and 3pm on 8 May 2015.
5.	Latchmere Lane, Ham – both sides, from its junction with Cowper Road to a point outside the southern boundary of No. 137 Latchmere Lane.	Between 1pm and 5pm on 5 May 2015 and between 1pm and 5pm on 8 May 2015.
