ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

Temporary Waiting Restrictions Christchurch Road, Westhay Gardens and West Temple Sheen, East Sheen

(Reference 15/048)

- 1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate construction works at Sheen Mount Primary School, they have made a temporary Traffic Order, the effect of which is to introduce a temporary prohibition of traffic in Christchurch Road, Westhay Gardens and West Temple Sheen, East Sheen.
- 2. (a) Whilst the works take place no person may permit a vehicle to wait or stand in the following lengths of street:-
 - Christchurch Road, from a point 10 metres west of its junction with West Temple Sheen to a point 10 metres east of its junction with West Temple Sheen;
 - (ii) Westhay Gardens, from its junction with West Temple Sheen, eastwards for a distance of 5 metres;
 - (iii) West Temple Sheen, the west side, from a point 10 metres south of its junction with Christchurch Road to a point opposite the common boundary of Nos 1 and 3 West Temple Sheen;
 - (iv) West Temple Sheen, the east side, from a point outside the common boundary of Nos 1 and 3 West Temple Sheen southwards to a point 20 metres north of its junction with Westhay Gardens;
 - (v) West Temple Sheen, the east side, from a point 10 metres south of its junction with Christchurch Road, northwards to a point 10 metres north of its junction with Christchurch Road.
 - (b) In order to facilitate large deliveries, on a number of occasions it will be necessary to introduce additional temporary waiting restrictions, of which notice will be provided in advance and indicated by signs/cones. Whilst these deliveries are taking place, no person may permit a vehicle to wait or stand in the following lengths of street:-
 - (i) West Temple Sheen, the east side, from a point 10 metres south of its junction with Christchurch Road, northwards to a point 20 metres north of its unction with Westhay Gardens;
 - (ii) Christchurch Road, from a point opposite the common boundary of Nos 79 and 81 Christchurch Road, eastwards to a point 10 metres west of its junction with West Temple Sheen.
- 3. The order will come into effect on 23 March 2015. The works are anticipated to be in progress from 23 March 2015 until 31 October 2015. The provisions of the order will be in force Mondays to Fridays between 9.30am and 2.30pm and between 4pm and 5pm and on Saturdays between 8am and 1pm where relevant signs/cones are placed for the restrictions outlined in Para 2(a) above, and on Mondays to Fridays between 8am and

6pm inclusive and on Saturdays between 8am and 1pm where relevant signs/cones are placed for the restrictions outlined in Para 2(b) above. The order will remain in force for a period of 18 months, to allow for unexpected events and possible remedial works.

- 4. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.
- 5. Nothing in the Order applies to:
 - (a) any vehicle being used in connection with the execution of the said works or any public service or utility vehicle;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
 - (c) emergency service vehicles, subject to site conditions at the time of any emergency.
- 6. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

Temporary Waiting Restrictions Christchurch Road, Westhay Gardens and West Temple Sheen, East Sheen

- 1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate construction works at Sheen Mount Primary School, they intend to make a temporary Traffic Order, the effect of which will be to introduce a temporary prohibition of traffic in Christchurch Road, Westhay Gardens and West Temple Sheen, East Sheen.
- 2. (a) Whilst the works take place no person may permit a vehicle to wait or stand in the following lengths of street:-
 - Christchurch Road, from a point 10 metres west of its junction with West Temple Sheen to a point 10 metres east of its junction with West Temple Sheen;
 - (ii) Westhay Gardens, from its junction with West Temple Sheen, eastwards for a distance of 5 metres;
 - (iii) West Temple Sheen, the west side, from a point 10 metres south of its junction with Christchurch Road to a point opposite the common boundary of Nos 1 and 3 West Temple Sheen;
 - (iv) West Temple Sheen, the east side, from a point outside the common boundary of Nos 1 and 3 West Temple Sheen southwards to a point 20 metres north of its junction with Westhay Gardens;
 - (v) West Temple Sheen, the east side, from a point 10 metres south of its junction with Christchurch Road, northwards to a point 10 metres north of its junction with Christchurch Road.
 - (b) In order to facilitate large deliveries, on a number of occasions it will be necessary to introduce additional temporary waiting restrictions, of which notice will be provided in advance and indicated by signs/cones. Whilst these deliveries are taking place, no person may permit a vehicle to wait or stand in the following lengths of street:-
 - (i) West Temple Sheen, the east side, from a point 10 metres south of its junction with Christchurch Road, northwards to a point 20 metres north of its unction with Westhay Gardens;
 - (ii) Christchurch Road, from a point opposite the common boundary of Nos 79 and 81 Christchurch Road, eastwards to a point 10 metres west of its junction with West Temple Sheen.
- 3. The order will come into effect on 23 March 2015. The works are anticipated to be in progress from 23 March 2015 until 31 October 2015. 

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY PROHIBITION OF TRAFFIC) (WEST TEMPLE SHEEN, EAST SHEEN) ORDER 2015

Made: 19 March 2015

Comes into operation: 23 March 2015

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted in order to facilitate school construction works (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order:-

Commencement and citation

1. This Order shall come into operation on 23 March 2015 and may be cited as the London Borough of Richmond upon Thames (Temporary Prohibition of Traffic) (West Temple Sheen, East Sheen) Order 2015 and shall remain in force for 18 months. The works are anticipated to be in progress from 23 March 2015 until 31 October 2015.

Prohibition or restriction of vehicular traffic

- 2. (a) Whilst the works take place from 23 March 2015 until 31 October 2015 between 9.30am and 2.30pm and between 4pm and 5pm on Monday to Fridays inclusive and between 8am and 1pm on Saturdays, no person may permit a vehicle to wait or stand in the following lengths of street:-
 - Christchurch Road, from a point 10 metres west of its junction with West Temple Sheen to a point 10 metres east of its junction with West Temple Sheen;
 - (ii) Westhay Gardens, from its junction with West Temple Sheen, eastwards for a distance of 5 metres;
 - (iii) West Temple Sheen, the west side, from a point 10 metres south of its junction with Christchurch Road to a point opposite the common boundary of Nos 1 and 3 West Temple Sheen;
 - (iv) West Temple Sheen, the east side; from a point outside the common boundary of Nos 1 and 3 West Temple Sheen southwards to a point 20 metres north of its junction with Westhay Gardens;
 - (v) West Temple Sheen, the east side, from a point 10 metres south of its junction with Christchurch Road, northwards to a point 10 metres north of its junction with Christchurch Road.

- (b) In order to facilitate large deliveries, on a number of occasions it will be necessary to introduce additional temporary waiting restrictions, of which notice will be provided in advance and indicated by signs/cones. Whilst these deliveries are taking place, on certain days between 30 March 2015 and 31 October 2015 between 8am, and 6pm on Mondays to Fridays inclusive and between 8am and 1pm on Saturdays no person may permit a vehicle to wait or stand in the following lengths of street:-
 - West Temple Sheen, the east side, from a point 10 metres south of its junction with Christchurch Road, northwards to a point 20 metres north of its unction with Westhay Gardens;
 - (ii) Christchurch Road, from a point opposite the common boundary of Nos 79 and 81 Christchurch Road, eastwards to a point 10 metres west of its junction with West Temple Sheen.
- 3. Nothing in Article 2 of this Order shall apply to any vehicle connected with the execution of the said works or to any public service or utility vehicle.
- 4. Nothing in this Order shall apply:-
 - (a) to anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
 - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion, provided that conditions which prevail on site at any one time do not render it unsafe or impossible for such a vehicle or vehicles to use any part of the public highway for the time being.
- 5. The provisions of this Order will only apply during such times when it is necessary to prohibit or restrict vehicular traffic in that road or length of road and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002(b).

Contravention

6. If a vehicle is left during the restricted time without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004(c) may then be issued by a civil enforcement officer in accordance with the requirements of that Act.

Manner of payment of the penalty charge

7. The penalty charge shall be paid to the Council as set out in Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011(d).

Alteration of position or removal of vehicles

8. Where any vehicle is standing in contravention of the provisions of this Order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may, under the provisions of the Removal and Disposal of Vehicles Regulations 1986(e), as amended, remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.
