

## ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

**Temporary Road Closures  
Hampton Court Road, Hampton Court**

(Reference 15/097)

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate the installation and removal of a temporary footbridge and other works in connection with the Hampton Court Flower Show they have made a temporary Traffic Order, the effect of which is that a section of Hampton Court Road will be closed to traffic on two occasions as set out below.
2. The section of road to be closed extends from the roundabout outside Hampton Court Palace (the junction of A309 Hampton Court Way and A308 Hampton Court Road) to its junction with Campbell Road, Hampton Court.
3. The dates and times when these road closures are anticipated to be in force are:-

1	Wednesday 24 June 2015 at 11.30pm	Thursday 25 June 2015 at 5.00am
2	Wednesday 8 July 2015 at 11.30pm	Thursday 9 July 2015 at 5.00am

4. An alternative route for eastbound traffic (Hampton Court Bridge towards Kingston Bridge) is via A308 Hampton Court Road (westwards), A311 Church Street, High Street Hampton, High Street Hampton Hill, A313 Hampton Road, Broad Street, High Street Teddington, A310 Kingston Road, Upper Teddington Road and High Street Hampton Wick. An alternative route for westbound traffic will be as above but in the reverse direction. This route is not suitable for vehicles over 15 feet and 9 inches (4.8 metres) high on account of a low bridge in High Street, Hampton Wick.
5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.
6. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

## TEMPORARY TRAFFIC MANAGEMENT ORDER

### THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY PROHIBITION OF TRAFFIC) (HAMPTON COURT ROAD, HAMPTON) ORDER 2015

Made: 11 June 2015

Comes into operation: 24 June 2015

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted from time to time in order to facilitate works to erect and later to remove a temporary footbridge to facilitate the Hampton Court Flower Show 2015 (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order:-

#### Commencement and citation

1. This Order shall come into operation on 24 June 2015 and may be cited as the London Borough of Richmond upon Thames (Temporary Prohibition of Traffic) (Hampton Court Road, Hampton) Order 2015 and shall remain in force for a maximum period of 6 months. The restrictions are expected to be in force on 24 until 25 June 2015 and again on 8 July 2015 until 9 July 2015.

#### Prohibition or restriction of vehicular traffic

2. Whilst the works takes place from 11.30pm on 24 June 2015 until 5.00am on 25 June 2015 and again from 11.30pm on 8 July 2015 until 5.00am on 9 July 2015 no person may cause any vehicle to:
  - (a) proceed in Hampton Court Road from the roundabout at its junction with Hampton Court Way (outside Hampton Court Palace) to its junction with Campbell Road; or
  - (b) wait or stand at any time in any part of Hampton Court Road, where, at the time, vehicular parking is restricted to facilitate the works.
3. Nothing in Article 2 of this Order shall apply to any vehicle connected with the execution of the said works or to any public service or utility vehicle.
4. Nothing in this Order shall apply:-

- (a) to anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
- (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion, provided that conditions which prevail on site at any one time do not render it unsafe or impossible for such a vehicle or vehicles to use any part of the public highway for the time being.
5. The provisions of this Order will only apply during such times when it is necessary or expedient to prohibit or restrict vehicular traffic in that road or length of road and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002**(b)**, as amended.

#### **Contravention**

6. If a vehicle is left during the restricted time without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004**(c)** may then be issued by a civil enforcement officer in accordance with the requirements of that Act.

#### **Manner of payment of the penalty charge**

7. The penalty charge shall be paid to the Council as set out in Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011**(d)**.

#### **Alteration of position or removal of vehicles**

8. Where any vehicle is standing in contravention of the provisions of this Order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may, under the provisions of the Removal and Disposal of Vehicles Regulations 1986**(e)**, as amended, remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.
