

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (2)

# Temporary Road Closure Lower Teddington Road, Hampton Wick



- 1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate a repair to a gas main, they will introduce a temporary road closure in Lower Teddington Road, Hampton Wick.
- 2. Whilst the works take place, no person shall cause or permit any vehicle to proceed, wait or stand in Lower Teddington Road from a point outside the north-eastern boundary of No 11 Lower Teddington Road to the south-western side of the railway bridge which crosses Lower Teddington Road.
- 3. An alternative route for vehicles affected by the closure will be available via High Street, Hampton Wick, Seymour Road and Station Road.
- 4. The provisions of this notice will come into force on 26 August 2015. Further details of the dates and times of the restrictions are contained in Paragraph 6.
- 5. Nothing in this Notice will apply to:
  - (a) any vehicle being used in connection with the execution of the said works; or
  - (b) anything done with the permission or at the direction of a police officer in uniform or a traffic warden.
- 6. The temporary restrictions will be introduced by a notice given under Section 14(2) of the Road Traffic Regulation Act 1984, as amended. The notice will come into effect on Wednesday 26 August 2015 and remain in force at all times for a period of 21 days or until the works are completed, whichever is the sooner. If the works extend beyond 15 September 2015, the Council will make an Order under the provisions of Section 14(1) of the said Act to continue in force the provisions of this Notice.
- 7. The restriction will apply only during such time and to such extent as indicated by prescribed traffic signs.

## Temporary Road Closure Lower Teddington Road, Hampton Wick

(Reference 15/154)

- 1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate emergency gas main repairs they have made a temporary Traffic Order the effect of which is to introduce a temporary prohibition of traffic in Lower Teddington Road, Hampton Wick.
- 2. Whilst the works take place, no person shall cause or permit any vehicle to proceed, wait or stand in Lower Teddington Road from a point outside the north-eastern boundary of No 11 Lower Teddington Road to the south-western side of the railway bridge which crosses Lower Teddington Road.
- 3. An alternative route for vehicles affected by the closure will be available via High Street, Hampton Wick, Upper Teddington Road, Station Road, Normansfield Avenue, Glamorgan Road and Seymour Road.
- 4. The order shall omen into effect on 5 September 2015 and continues in force the provisions of a Notice made under Section 14(2) of the Road Traffic Regulation Act 1984 which came into force on 26 August 2015. The works are anticipated to be in progress until 18 September 2015. The provisions of the order will be in force at all times where relevant signs/cones are placed. The order will remain in force for a period of 18 months, to allow for unexpected events and possible remedial works.
- 5. Nothing in this Notice will apply to:
  - (a) any vehicle being used in connection with the execution of the said works; or
  - (b) anything done with the permission or at the direction of a police officer in uniform or a traffic warden.
- 6. The restriction will apply only during such time and to such extent as indicated by prescribed traffic signs.
- 7. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

## **TEMPORARY TRAFFIC MANAGEMENT ORDER**

### THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY PROHIBITION OF TRAFFIC) (LOWER TEDDINGTON ROAD. HAMPTON WICK) ORDER 2015

Made: 3 September 2015

Comes into operation: 5 September 2015

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted in order to facilitate emergency gas main repair woks (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order:-

#### **Commencement and citation**

1. This Order shall come into operation on 5 September 2015 and may be cited as the London Borough of Richmond upon Thames (Temporary Prohibition of Traffic) (Lower Teddington Road, Hampton Wick) Order 2015 and shall remain in force for 18 months. The works are anticipated to be in progress from 5 September 2015 until 18 September 2015.

#### Prohibition or restriction of vehicular traffic

- 2. Whilst the works take place, at all times from 5 September 2015 until 18 September 2015 no person shall cause or permit any vehicle to proceed, wait or stand in Lower Teddington Road from a point outside the north-eastern boundary of No 11 Lower Teddington Road to the south-western side of the railway bridge which crosses Lower Teddington Road.
- 3. Nothing in Article 2 of this Order shall apply to any vehicle connected with the execution of the said works or to any public service or utility vehicle.
- 4. Nothing in this Order shall apply:-

...

- (a) to anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
- (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion, provided that conditions which prevail on site at any one time do not render it unsafe or impossible for such a vehicle or vehicles to use any part of the public highway for the time being.

5. The provisions of this Order will only apply during such times when it is necessary to prohibit or restrict vehicular traffic in that road or length of road and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002(b).

#### Contravention

6. If a vehicle is left during the restricted time without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004(c) may then be issued by a civil enforcement officer in accordance with the requirements of that Act.

#### Manner of payment of the penalty charge

7. The penalty charge shall be paid to the Council as set out in Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011(d).

#### Alteration of position or removal of vehicles

8. Where any vehicle is standing in contravention of the provisions of this Order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may, under the provisions of the Removal and Disposal of Vehicles Regulations 1986(e), as amended, remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.
