#### ROAD TRAFFIC REGULATION ACT 1984 - SECTION 16A

#### THE LONDON BOROUGH OF RICHMOND UPON THAMES (VARIOUS CHRISTMAS EVENTS ACROSS THE BOROUGH) ORDER 2015

#### Various Christmas Events Across the Borough (Ref 15/200)

- 1. The Council of the London Borough of Richmond upon Thames on 19 November 2015 made the above Order under section 16A of the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the order is to facilitate the holding of Christmas events in various borough roads.
- 3. During the dates and times specified in the schedule, no vehicle will be permitted to enter, proceed, wait or stand in the length of street described, where relevant signs and/or cones are placed.
- 4. Nothing in the Order will apply to:
  - (a) anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
  - (b) any vehicle being used by an emergency service, whereby it is necessary by reason of an emergency, for that vehicle to have access to part of the street under restriction.
- 5. Copies of the Order:-
  - (a) can be inspected for a period of 6 weeks by quoting 15/200 at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and
  - (b) may be viewed on the Council's web-site at <u>http://www.richmond.gov.uk/public\_notices</u>.
- 6. The prohibitions apply only during such times and to such extent as indicated by prescribed traffic signs.
- 7. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.



# **TEMPORARY TRAFFIC MANAGEMENT ORDER**

# THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY RESTRICTION OF TRAFFIC) (VARIOUS CHRISTMAS EVENTS ACROSS THE BOROUGH) ORDER 2015

Made: 19 November 2015

Comes into operation: 22 November 2015

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the traffic authority for all roads within the said London borough, with the exception of those roads which are part of the Transport for London Road Network and those which are Crown roads within the Royal Parks of Richmond Park and Bushy Park, (hereinafter referred to as "the borough roads") is satisfied that events, the particulars of which are given in Article 2 of the following order, should be held on certain of the borough roads and that vehicular traffic should be prohibited and parking restricted in order to facilitate the holding of those events.

NOW THEREFORE the Council in exercise of the powers conferred by Section 16A of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby makes the following Order:

#### **Commencement and citation**

- 1. (1) This Order shall come into operation on 22 November 2015 and may be cited as the London Borough of Richmond upon Thames (Temporary Restriction of Traffic) (Various Christmas Events Across the Borough) Order 2015 and, subject to the provisions of paragraph (2) of this Article, shall remain in force until 17 December 2015.
  - (2) This order shall remain in force for one day only in respect of each event for which this order is made.

#### Interpretation

- 2
- (1) In this order, the following expressions shall have the meanings hereinafter assigned:-

"police community support officer" shall mean a person who has been designated as such by the Metropolitan Police Service as provided for by section 38 of the Police Reform Act 2002(b) and is wearing an approved uniform as provided for by section 41 of that Act;

"specified street" means the street specified in column 2 of any item in the Schedule to this order, where the area of the borough in which that street is located is the district specified in column 3 of that item and, where a part of that street is specified in column 4 of that item, then the specified street shall mean only that part of that street;

"specified date" and "specified hours" in relation to any specified street shall mean respectively the date specified in column 5 and the hours specified in column 6 of the item relevant to the specified street;

Provided that in any item where column 2 is divided into more than one row the specified street shall mean the street specified in each of those rows and the specified part of that street and specified hours shall mean the parts and hours specified in the corresponding rows of columns 4 and 6, as appropriate.

- (2) The events for which this order is made are the public switching on Christmas lights and illumination at a number of sites across the borough as set out in the schedule to this order which, in each case is an entertainment and for which the Council is satisfied that it is not reasonably practical for it to be held other than on a road.
- (3) The Interpretation Act 1978(c) shall apply for the interpretation of this order as it applies to the interpretation of an Act of Parliament.

#### Prohibition or restriction of vehicular traffic

- 3. (a) No person may cause or permit any vehicle to enter, proceed or wait in any specified street on the specified date during the specified hours described in the schedule, where relevant signs and/or no parking cones are placed;
  - (b) On Sunday 22 November 2015 between 12 noon and 9pm, Item 5 in Schedule 1 of the London Borough of Richmond upon Thames (Prescribed Routes) (Bus Lanes) (Amendment No 7) Order 2014(d) shall be suspended, the effect being to permit the "Santa Express" vehicle to proceed in the bus lane sited on the northern side of Heath Road, Twickenham.

#### Exemptions

- 4. Nothing in Article 3 of this Order shall apply to any vehicle being used in connection with the said event or to any public service or utility vehicle.
- 5. Nothing in this Order shall apply:
  - (a) to anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or a Police Community Support Officer.
  - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion.

#### **Traffic Signs**

6. The provisions of this Order will only apply during such times when it is necessary to prohibit or restrict vehicular traffic in the road(s) or length of road(s) specified in Article 3 above and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002(e).

#### Contravention

7. If a vehicle is left during the restricted hours without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004(c) may then be issued by a civil enforcement officer in accordance with the requirements of the said Act.

#### Manner of payment of the penalty charge

8. The penalty charge shall be paid to the Council as provided for by Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011(f).

#### Alteration of position of/or removal of vehicles

9. Where any vehicle is standing in contravention of the provisions of this Order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.
