

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

**Temporary Footpath Closure
Footpath between Clonmel Road and the Railway
Footbridge which leads to Fulwell Railway Station**

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate ground investigation works they have made a temporary Traffic Order, the effect of which is to introduce a footpath closure between Clonmel Road and the footbridge which leads to Fulwell Railway Station, Teddington.
2. Whilst the works take place no person may proceed in the footpath which links Clonmel Road at the Wellington Road end and the southern side of the passenger footbridge to Fulwell Railway Station.
3. Whilst the closure is in effect, an alternative route for pedestrians will be via Clonmel Road and the passenger footpath leading to the railway station.
4. The order will come into effect on 11 January 2016. The works are anticipated to be in progress from 11 January 2016 until 18 January 2016. The provisions of the order will be in force at all times where relevant signs are placed. The order will remain in force for a period of 6 months, to allow for unexpected events and possible remedial works.
5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.

1. TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY CLOSURE OF FOOTPATH) (FOOTPATH LINKING CLONMEL ROAD AND FULWELL STATION, TEDDINGTON) ORDER 2016

Made: 7 January 2016

Comes into operation: 11 January 2016

WHEREAS the Council of the London Borough of Richmond upon Thames being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network, are satisfied that pedestrian traffic should be prohibited along the footpath which links Clonmel Road at the Wellington Road end and the southern side of the passenger footbridge to Fulwell Railway Station in order to facilitate ground investigation works (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended by the Road Traffic (Temporary Restrictions) Act 1991(b) and by other enactments, and of all other enabling powers hereby make the following Order:-

Commencement and citation

1. This Order shall come into operation on 11 January 2016 and may be cited as the London Borough of Richmond upon Thames (Temporary Closure of Footpath) (Footpath Linking Clonmel Road and Fulwell Station, Teddington) Order 2016 and shall remain in force for a period of 6 months.


Interpretation

2. (1) In this order, the following expressions shall have the meanings hereby assigned to each respectively:-
 - "The Council" means Council of the London Borough of Richmond upon Thames;
 - "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) The Interpretation Act 1978(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Prohibition or restriction of pedestrian traffic

3. (1) Whilst the works takes place no person shall be permitted to proceed in the footpath which links Clonmel Road at the Wellington Road end and the southern side of the passenger footbridge to Fulwell Railway Station.
- (2) Nothing in paragraph (1) of this Article shall apply to any person engaged in the execution of the works or who may be visiting the works, or any person acting on behalf of the emergency services.
