

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

**Temporary Footpath Closure
Railway Passage, Teddington**

(Ref: 16/014)

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate sewer repair works they have made a Temporary Traffic Order the effect of which is to introduce a footpath closure in Railway Passage, Teddington.
2. Whilst the works take place no person may proceed in Railway Passage between its junctions with Victoria Road and Clarence Road, where signs are in place. Access will be maintained where possible.
3. The order shall come into effect on 16 January 2016 and continues in force the provisions of a Notice made under Section 14(2) of the Road Traffic Regulation Act 1984 which came into force on 11 January 2016. The provisions of the order will be in force at all times inclusive where relevant signs/cones are placed. The order will remain in force for a period of 6 months, or until the works are completed, whichever is the sooner. The works are expected to be completed by 30 April 2016.
4. Nothing in the Order applies to:
 - (a) any vehicle being used, or any person in connection with the execution of the said works;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (c) any vehicle being used, or any person needing access for police, fire brigade or ambulance purposes.
5. The prohibitions will apply only during such time and to such extent as indicated by prescribed traffic signs.

**Temporary Footpath Closure
Railway Passage, Teddington**

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that due to the need to facilitate sewer repair works they will introduce a footpath closure in Railway Passage, Teddington.
2. Whilst the works take place no person may proceed in Railway Passage between its junctions with Victoria Road and Clarence Road, where signs are in place. Access will be maintained where possible.
3. The restrictions will come into force on 11 January 2016. Further details regarding the dates and times of the closure are explained in paragraph 6 of this notice.
4. An alternative route for pedestrianism will be available via Victoria Road and Clarence Road and vice versa.
5. Nothing in this Notice will apply to:
 - (a) any vehicle being used, or any person in connection with the execution of the said works;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (c) any vehicle being used, or any person needing access for police, fire brigade or ambulance purposes.
6. The temporary restrictions will be introduced by a notice given under Section 14(2) of the Road Traffic Regulation Act 1984, as amended. The notice will come into effect on 11 January 2016 and remain in force until 15 January 2016, that is, for a period of 5 days. After this, the Council will introduce an Order under S14(1) of the said Act to continue in force the provision of this Notice for up to 6 months or until the works are completed, whichever is the sooner.
7. The prohibitions will apply only during such time and to such extent as indicated by prescribed traffic signs.
8. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY CLOSURE OF FOOTPATH) (RAILWAY PASSAGE, TEDDINGTON) ORDER 2016

Made: 14 January 2016

Comes into operation: 16 January 2016

WHEREAS the Council of the London Borough of Richmond upon Thames being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network, are satisfied that pedestrian traffic should be prohibited along the footpath known as Railway Passage, Teddington which links Victoria Road and Clarence Road Teddington in order to facilitate a sewer repair (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended by the Road Traffic (Temporary Restrictions) Act 1991(b) and by other enactments, and of all other enabling powers hereby make the following Order:-

Commencement and citation

1. This Order shall come into operation on 16 January 2016 and may be cited as the London Borough of Richmond upon Thames (Temporary Closure of Footpath) (Railway Passage, Teddington) Order 2016 and shall remain in force for a period of 6 months.

Interpretation

2. (1) In this order, the following expressions shall have the meanings hereby assigned to each respectively:-


"The Council" means Council of the London Borough of Richmond upon Thames;

"enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) The Interpretation Act 1978(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Prohibition or restriction of pedestrian traffic

3. (1) Whilst the works takes place no person shall be permitted to proceed in Railway Passage, Teddington which links Victoria Road and Clarence Road, Teddington.
- (2) Nothing in paragraph (1) of this Article shall apply to any person engaged in the execution of the works or who may be visiting the works, or any person acting on behalf of the emergency services.
