# Temporary Bus Lane Suspension Castelnau, Barnes

(Reference 16/019)

- The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate sewer repair works they have made a Temporary Traffic Order the effect of which is to introduce a bus lane suspension on Castelnau, Barnes.
  - 2. Whilst the works take place, all vehicular traffic will be permitted to proceed in the bus lane on the north-western side of Castelnau, from its junction with Washington Road, north-eastwards for a distance of 100 metres at all times whist the Order is in effect.
  - 3. The order came into effect on 27 January 2016 and continues in force the provisions of a Notice made under Section 14(2) of the Road Traffic Regulation Act 1984 which came into force on 22 January 2016. The provisions of the order will be in force at all times where relevant signs are placed. The order will remain in force for a period of 18 months, or until the works are completed, whichever is the sooner. The works are expected to be completed by 19 February 2016.
  - 4. Nothing in the Order applies to:
    - any vehicle being used, or any person in connection with the execution of the said works;
    - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
    - (c) any vehicle being used for police, fire brigade or ambulance purposes.

# Temporary Bus Lane Suspension Castelnau, Barnes

- 1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate sewer repair works they will temporarily suspend the bus lane in Castelnau, Barnes.
- 2. Whilst the works take place, all vehicular traffic will be permitted to proceed in the bus lane on the north-western side of Castelnau, from its junction with Washington Road, north-eastwards for a distance of 100 metres at all times whist this Notice is in effect.
- 3. The suspension will come into force at 8am on 22 January 2016. It is anticipated that the suspension will remain in place until 19 February 2016.
- 4. Nothing in this Notice will apply to:
  - (a) any vehicle being used in connection with the execution of the said works;
  - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
  - (c) any vehicle being used for police, fire brigade or ambulance purposes.
- 5. The measures described will be introduced by this notice given under Section 14(2) of the Road Traffic Regulation Act 1984, as amended. The notice will come into effect on 22 January 2016 and remain in force for a period of 5 days, After this, the Council will make an Order under S14(1) of the said Act to continue in force the provisions of this Notice for 18 months, or until the works are completed, whichever is the sooner.
- 6. The restriction will apply only during such time and to such extent as indicated by prescribed traffic signs.

# TEMPORARY TRAFFIC MANAGEMENT ORDER

# THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY SUSPENSION OF BUS LANE) (CASTELNAU, BARNES) ORDER 2016

Made: 26 January 2016

Comes into operation: 27 January 2016

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that a length of cycle lane should be suspended in order to facilitate repairs to a collapsed sewer (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order:-

### Commencement and citation

1. This Order shall come into operation on 27 January 2016 and may be cited as the London Borough of Richmond upon Thames (Temporary Suspension of Bus Lane) (Castelnau, Barnes) Order 2016 and shall remain in force for a maximum period of 18 months. The works are anticipated to be in progress from 27 January 2016 until 19 February 2016.

### **Provisions and Exemptions**

- 2. Whilst the works take place, at all times from 27 January 2016 until 19 February 2016 inclusive, the provisions of Item 1(a) of Schedule 1 to the London Borough of Richmond upon Thames (Reserved Bus Lanes) (Consolidation) Order 2005(b) shall be suspended insofar as they apply to that length of bus lane which is sited on the north-west side of Castelnau, from the common boundary of Nos 5 and 7 Castelnau to a point 3 metres south-west of the common boundary of Nos 171 and 173 Castelnau.
- 3. Nothing in Article 2 of this Order shall apply to any vehicle connected with the execution of the said works or to any public service or utility vehicle.
- 4. Nothing in this Order shall apply:-
  - (a) to anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
  - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion, provided that conditions which prevail on site at any one time do not render it unsafe or

impossible for such a vehicle or vehicles to use any part of the public highway for the time being.

5. The provisions of this Order will only apply during such times when it is necessary to suspend the bus lane and/pr loading restriction in that road or length of road and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002(d).
