

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

**Temporary Road Closure
Duke Street, Richmond**

(Reference 16/046)

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate water utility works they have made a temporary Traffic Order, the effect of which is to introduce a temporary prohibition of traffic in Duke Street, Richmond
2. Whilst the works take place, no person shall cause or permit any vehicle to proceed in Duke Street between its junctions with Quadrant Road and George Street.
3. The order will come into effect on 28 March 2016. The restrictions will be in force from 9.30am on 28 March 2016 until 5pm on 30 March 2016 whilst signs are in place. The order will remain in force for a period of 18 months, to allow for unexpected events and possible remedial works.
4. An alternative route for vehicles affected by the closure of Duke Street will be available via Little Green, Parkshot, Clarence Street, Kew Road, A316 Richmond Circus, Kew Road, and The Quadrant.
5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.
6. Nothing in the Order applies to:
 - (a) any vehicle being used in connection with the execution of the said works or any public service or utility vehicle;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (c) emergency service vehicles, subject to site conditions at the time of any emergency.
7. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY PROHIBITION OF TRAFFIC) (DUKE STREET, RICHMOND) ORDER 2016

Made: 10 March 2016

Comes into operation: 28 March 2016

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted in order to facilitate water utility works (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order:-

Commencement and citation

1. This Order shall come into operation on 28 March 2016 and may be cited as the London Borough of Richmond upon Thames (Temporary Prohibition of Traffic) (Duke Street, Richmond) Order 2016 and shall remain in force for 18 months. The works are anticipated to be in progress from 28 March 2016 until 30 March 2016.

Prohibition or restriction of vehicular traffic

2. Whilst the works take place, from 9.30am on 28 March 2016 until 5pm on 30 March 2016 no person shall cause or permit any vehicle to proceed in Duke Street between its junctions with Quadrant Road and George Street.
3. Nothing in Article 2 of this Order shall apply to any vehicle connected with the execution of the said works or to any public service or utility vehicle.
4. Nothing in this Order shall apply:-
 - (a) to anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion, provided that conditions which prevail on site at any one time do not render it unsafe or impossible for such a vehicle or vehicles to use any part of the public highway for the time being.
