

**ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14****Temporary Road Closure  
Castelnau, Barnes**  
(Reference 16/050)

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate the safe movement of traffic and to prevent the likelihood of danger to the public, they have made a temporary traffic Order to restrict vehicular traffic in Castelnau, Barnes to facilitate the holding of the 2016 University Boat Races.
2. Whilst this Order is in force, a Police officer in uniform is permitted to order the closure in whole or in part, and restrict stopping, waiting, loading and unloading to all vehicles on some or all of Castelnau, Barnes between Hammersmith Bridge and its junction with Lonsdale Road before, during and after the 2016 University Boat Races on the River Thames. Further details regarding the dates and times of the restrictions are explained in paragraph 4 of this notice.
3. Whilst the restrictions are in force, local access will be maintained, whenever possible, with the permission of a police constable in uniform.
4. The Order will come into effect on Friday 25 March 2016 at 00.01, and will be in force at such times as ordered by a police constable in uniform until Sunday 27 March 2016 at 23.59.
5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.
6. Nothing in the notice applies to:
  - (a) any vehicle being used for police, ambulance or fire brigade purposes;
  - (b) anything done with the permission or at the direction of a police officer in uniform.
7. Any vehicle waiting in contravention of any restriction imposed by the notice may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

## TEMPORARY TRAFFIC MANAGEMENT ORDER

### THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY PROHIBITION OF TRAFFIC) (BOAT RACE) ORDER 2016

Made: 10 March 2016

Comes into operation: 25 March 2016

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted because of the likelihood of danger to the public.

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1)(b) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order:-

#### Commencement and citation

1. This Order shall come into operation on 25 March 2016 and may be cited as the London Borough of Richmond upon Thames (Temporary Prohibition of Traffic) (Boat Race) Order 2016. The restrictions will be in force from 00.01 on 25 March 2016 until 23.59 on 27 March 2016

#### Prohibition or restriction of vehicular traffic

2. Whilst this Order is in force, a Police officer in uniform is permitted to order the closure in whole or in part, and restrict stopping, waiting, loading and unloading to all vehicles on some or all of Castelnau, Barnes between Hammersmith Bridge and its junction with Lonsdale Road before, during and after the 2016 University Boat Races on the River Thames
3. Nothing in Article 2 of this Order shall apply to any public service or utility vehicle.
4. Nothing in this Order shall apply:-
  - (a) to anything done with the permission or at the direction of a police officer in uniform; or
  - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion, provided that conditions which prevail on site at any one time do not render it unsafe or impossible for such a vehicle or vehicles to use any part of the public highway for the time being.

5. The provisions of this Order will only apply during such times when it is necessary to prohibit or restrict vehicular traffic in that road or length of road and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002**(b)**.

**Contravention**

6. If a vehicle is left during the restricted time without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004**(c)** may then be issued by a civil enforcement officer in accordance with the requirements of that Act.


**Manner of payment of the penalty charge**

7. The penalty charge shall be paid to the Council as set out in Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011**(d)**.

**Alteration of position or removal of vehicles**

8. Where any vehicle is standing in contravention of the provisions of this Order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may, under the provisions of the Removal and Disposal of Vehicles Regulations 1986**(e)**, as amended, remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.
