**DISABLED PERSONS PARKING BAYS  
VARIOUS STREETS THROUGHOUT THE BOROUGH**

(Reference 16/077)

1. The Council of the London Borough of Richmond upon Thames on 25 August 2016 made the above Order under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
2. The principal objective of the Order is to introduce a number of parking places for disabled persons where a high level of parking makes reasonable means of access difficult, to relocate an existing parking place and to discontinue a parking place previously provided where the demand for such bays no longer exists.
3. The Order will introduce a parking bay for disabled persons' vehicles, operating "at any time" in the following streets:  

Haliburton Road, Twickenham;	St Margarets Road, Isleworth; and
Roy Grove, Hampton;	
4. The Order will relocate a bay sited outside No 11 Buckingham Road, Petersham so that it is located some 5 metres north-east of the current location.
5. Copies of the Order, which comes into force on 30 August 2016, plans showing the location and effect of the Order and the Council's Statement of Reasons for making the Order:-
  - (a) can be inspected, quoting Reference 16/077 at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and
  - (b) may be viewed on the Council's web-site at [http://www.richmond.gov.uk/public\\_notices](http://www.richmond.gov.uk/public_notices)
6. Persons wishing to question the validity of this Order or any of its provisions on the grounds that it or they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Order was made, apply for the purpose to the High Court

1. This Order shall come into operation on 30 August 2016 and may be cited as the London Borough of Richmond upon Thames (Free Parking Places) (People with Disabilities) (Amendment No. 54) Order 2016.
2.
  - (1) In this Order the expression “enactment” means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
  - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
  - (3) The Interpretation Act 1978(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Free Parking Places) (People with Disabilities) Order 2007(c), as amended, shall have effect as though
  - (a) there were added to the items in Schedule 2 to that Order the items numbered 95C and 203C as set out in columns 1, 2, 3 and 4 of Schedule 1 to this Order;
  - (b) there were substituted for the items numbered 23 and 207B the items similarly numbered and set out in columns 1, 2, 3 and 4 of Schedule 2 to this Order.

The bays are situated: -

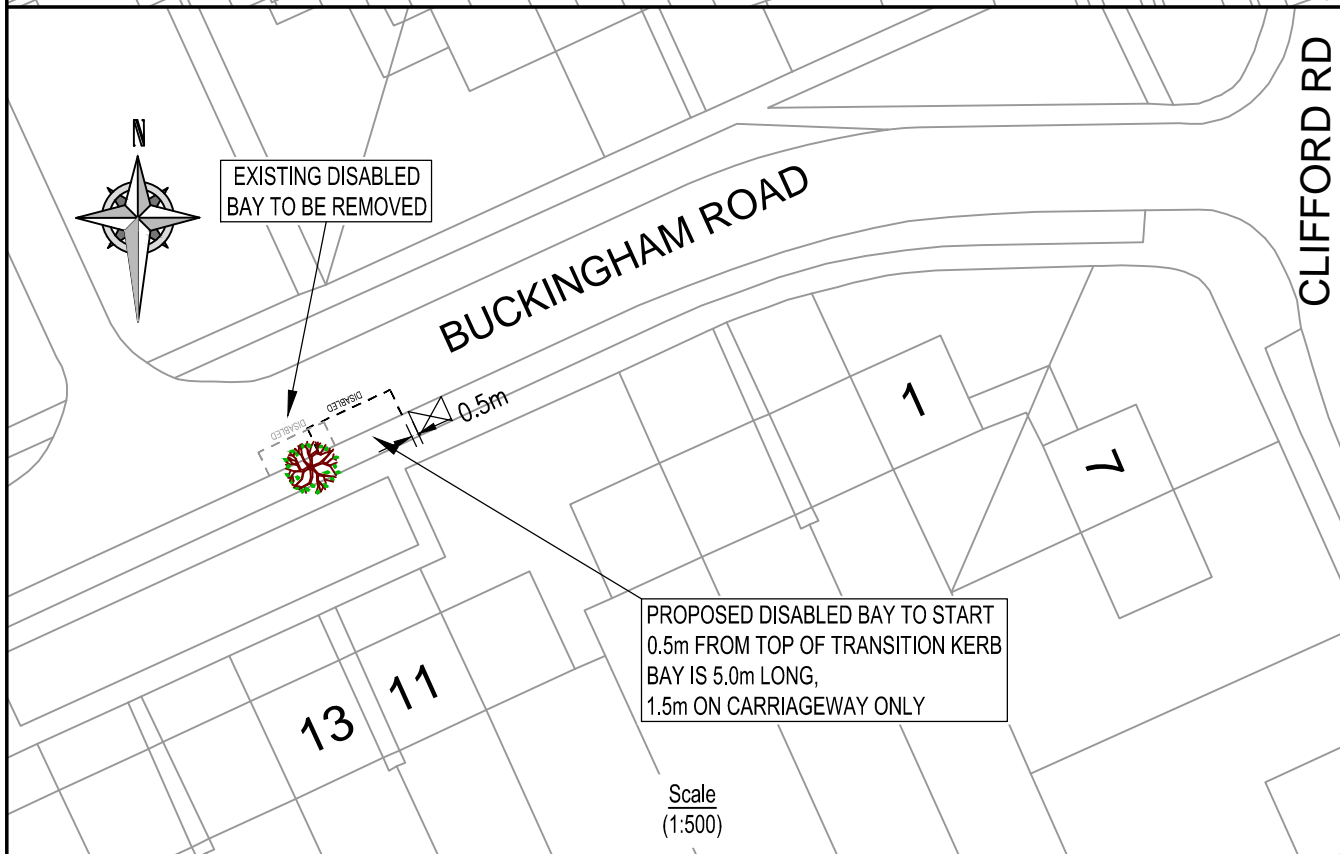
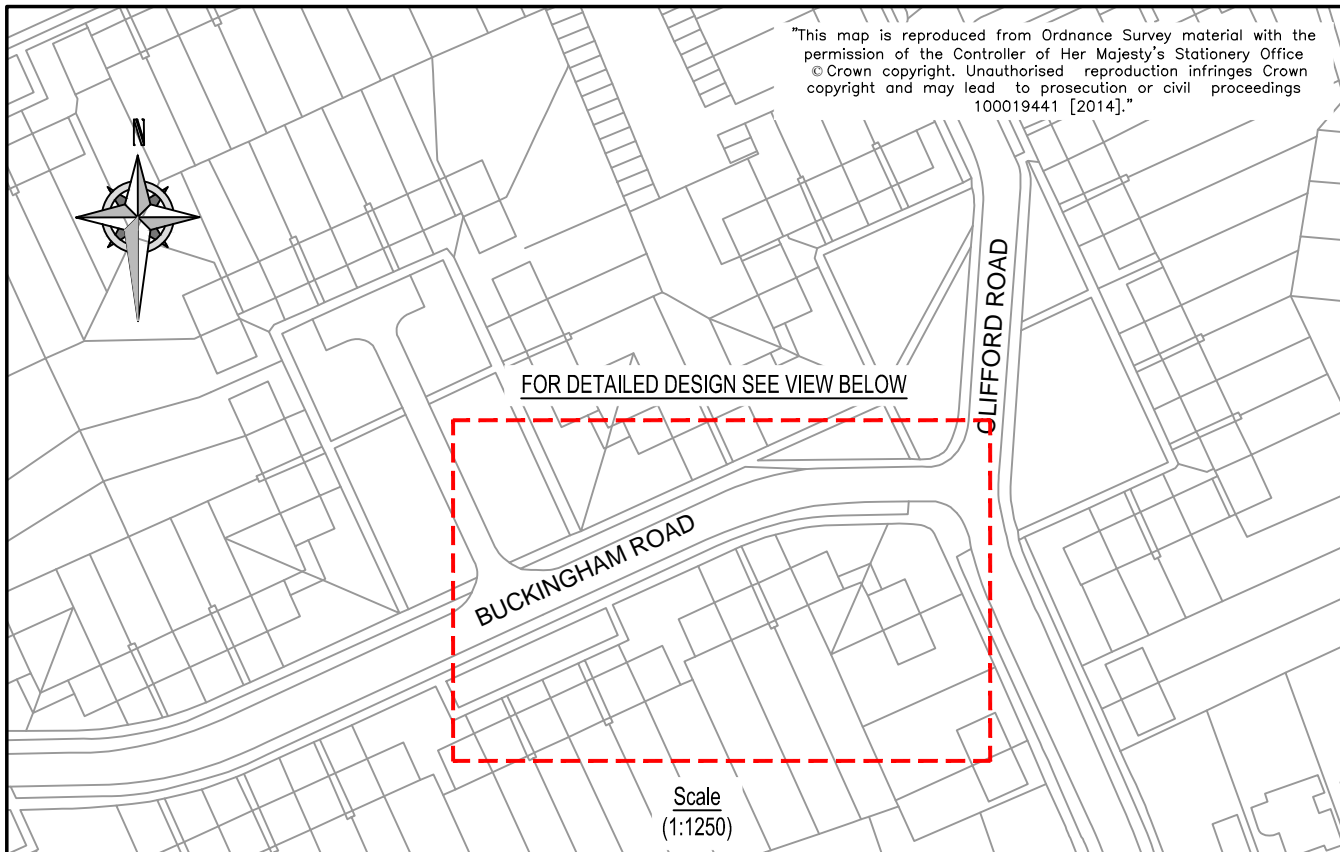
- (i) outside Nos 11 Buckingham Road, Petersham;
