#### OLD BRIDGE STREET CAR PARK, HAMPTON WICK (Reference 16/132)

- 1. The Council of the London Borough of Richmond upon Thames proposes to make the above Order under sections 32, 35 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Order will be to amend the operational hours of the off-street car park in Old Bridge Street, Hampton Wick and to make changes to the parking charges which operate in that car park. The new scale of parking charges, before any discounts are applied, are referred to in this Notice and the proposed order as the "Tier 3" charge. The standard charges currently in force will be increased by an average of 9%.
- 3. For residents of the borough under the age of 75, a discount of 10% of the Tier 3 charge or free parking for a stay of no more than 30 minutes will apply. For the purpose of this Notice and the proposed order, this is known as the "Tier 2" charge.
- 4. For residents over the age of 75, the discount will be 20% of the Tier 3 charge or the concessionary free parking period for a stay of no more than 30 minutes. For the purpose of this Notice and the proposed order, this is known as the "Tier 1" charge.
- 5. Nothing in this Notice or in the proposed order will prevent the Council from using other terms or expressions to indicate the three-tier charging structure in publicity material or at the time when the new charges may or will come into force.
- 6. Details of the current standard charges for the Old Bridge Street car park are given in the Schedule to this Notice together with details of the proposed variation to the standard charge and changes to operational and charge hours.
- 7. Copies of the proposed Order, plans showing the location of the car park and the Council's Statement of Reasons for proposing to make the Order can:-
  - (a) be inspected, quoting Reference 16/132, at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; or

#### PART 1

#### Preliminary and general provisions

#### Citation and commencement

- (1) This Order may be cited as the London Borough of Richmond upon Thames (Off-Street Parking Places) (Civil Enforcement) (Amendment No \*) Order 201\* and shall come into operation on \*\* \*\*\* \*\*\*\*
- 2. (1) In this Order the expression "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.

(2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

(3) The Interpretation Act 1978(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Off-Street Parking Places) (Civil Enforcement) (Amendment No \*) Order 2011 (c), as amended, shall have effect as though for the item numbered 1/10 in Schedule 1 to that Order, there was substituted the item similarly numbered and set out in columns 1 to 11 to this Order.
