Temporary Towpath Closure Hammersmith to Kew Towpath

(Reference 16/196)

- 1. The Council of the London Borough of Richmond upon Thames, with the agreement of the London Borough of Hammersmith and Fulham HEREBY GIVES NOTICE that to facilitate maintenance to the river bank of the River Thames they have made a temporary Traffic Order, the effect of which is to introduce a temporary prohibition of traffic and pedestrians on a length of the towpath along the River Thames between Hammersmith Bridge and Kew.
- Whilst the works take place no person shall enter or proceed in the riverside towpath (and the access path to the towpath adjacent to the upstream side of the bridge) between Hammersmith Bridge and the Swedish School on Lonsdale Road, Barnes.
- 3. The order will come into effect on 29 September 2016. The restrictions will be in force at all times from 29 September 2016 until 4 November 2016 inclusive. The order will remain in force for a period of 6 months, to allow for unexpected events and possible remedial works.
- 4. An alternative route for pedestrians will be available via the downstream side of Hammersmith Bridge, Castelnau, Lonsdale Road, the footpath that runs adjacent to the Swedish School, and the footpath leading to the river towpath.
- 5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.
- 6. Nothing in the Order applies to:
 - (a) any vehicle being used, or any person in connection with the execution of the said works;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (c) any vehicle being used, or any person needing access for police, fire brigade or ambulance purposes.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY CLOSURE OF TOWPATH) (TOWPATH BETWEEN HAMMERSMITH BRIDGE AND KEW) ORDER 2016

Made: 22 September 2016

Comes into operation: 29 September 2016

WHEREAS the Council of the London Borough of Richmond upon Thames being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network, with the agreement of the London Borough of Hammersmith and Fulham and the Port of London Authority are satisfied that pedestrian traffic should be prohibited in the towpath along the River Thames between Hammersmith Bridge and Kew to facilitate riverbank restoration works (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended by the Road Traffic (Temporary Restrictions) Act 1991(b) and by other enactments, and of all other enabling powers hereby make the following Order:-

Commencement and citation

This Order shall come into operation on 29 September 2016 and may be cited as the London Borough of Richmond upon Thames (Temporary Closure of Towpath) (Towpath between Hammersmith Bridge and Kew) Order 2016 and shall remain in force for a period of 6 months.

Interpretation

- 2. (1) In this order, the following expressions shall have the meanings hereby assigned to each respectively:-
 - "The Council" means Council of the London Borough of Richmond upon Thames;
 - "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Prohibition or restriction of pedestrian traffic

- 3. (1) Whilst the works take place, at all times from 29 September 2016 until 4
 November 2016 no person shall enter or proceed in the riverside towpath (and the access path to the towpath adjacent to the upstream side of the bridge) between Hammersmith Bridge and the Swedish School in Lonsdale Road, Barnes.
 - (2) Nothing in paragraph (1) of this Article shall apply to any person engaged in the execution of the works or who may be visiting the works, or any person acting on behalf of the emergency services.
