# EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order provides for the inclusion of Worple Road, Isleworth into the Twickenham Stadium Event Day Zone.

### STATEMENT OF REASONS

Following representations from residents in Worple Road, Isleworth, it has been resolved to extend the Twickenham Stadium Event Days Parking Zone to include these roads. On Event Days visitors to Twickenham Stadium have been parking in these roads and this has resulted in residents not being able to access their properties.
