

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

**Temporary Closure of Public Right of Way
PRW 138 between Kings Road and Worple Way,
Richmond**

(Reference 17/083)

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate a water disconnection, they intend to make a temporary Traffic Order, the effect of which will be to introduce a temporary footpath closure of a section of PRW 138.
2. Whilst the works take place, no person shall enter PRW 138 between its junction with Kings Road and a point outside No 75 Worple Way. Richmond.
3. The order will come into effect on 5 June 2017. The restrictions will be in force at all times from 5 June 2017 until 12 June 2017 and whilst signs/cones are in place. The order will remain in force for a period of 6 months, to allow for unexpected events and possible remedial works.
4. An alternative route for pedestrians will be available via Worple Way, Sheen Road and Kings Road.
5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY CLOSURE OF FOOTPATH) (PUBLIC RIGHT OF WAY LINKING KINGS ROAD AND WORPLE WAY, RICHMOND) ORDER 2017

Made: 1 June 2017

Comes into operation: 5 June 2017

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted in order to facilitate a water disconnection (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order:-

Commencement and citation

1. This Order shall come into operation on 5 June 2017 and may be cited as the London Borough of Richmond upon Thames (Temporary Closure of Footpath) (Public Right of Way Linking Kings Road and Worple Way, Richmond) Order 2017 and shall remain in force for a period of six months, or until the works are completed, whichever is the sooner.

Interpretation

- 2, (1) In this order, the following expressions shall have the meanings hereby assigned to each respectively:-

"The Council" means Council of the London Borough of Richmond upon Thames;


"enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) The Interpretation Act 1978(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Prohibition or restriction of pedestrian traffic

3. (1) At all times, from 5 June 2017, until 12 June 2017, no person shall enter PRW 138 between its junction with Kings Road and a point outside No 75 Worple Way, Richmond. The Order shall remain in force for a period of six months to allow for unexpected events and possible remedial works.
- (2) Nothing in paragraph (1) of this Article shall apply to
- (a) any person engaged in the execution of the said works
 - (b) anything done with the permission or at the direction of a police officer in uniform.
