
Temporary Road Closure and Waiting Restrictions Hospital Bridge Road and Tennyson Avenue, Twickenham



- The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate filming on the public highway and to allow access for filming off-highway, they have made a temporary Order, the effect of which is to introduce restrictions in Hospital Bridge Road and Tennyson Avenue, Twickenham.
- 2. Whilst the filming is in progress:,
 - (a) no person may permit a vehicle to enter, proceed, wait or stand in Tennyson Avenue. Access will be maintained from Cross Deep Gardens. These restrictions will be in force between 1pm and 7pm on Friday 23 June 2017 only;
 - (b) no person shall cause or permit any vehicle to wait or stand on the western side of Hospital Bridge Road, from a point outside the common boundary of Nos 143/145 Hospital Bridge Road to a point outside the northern boundary of No 157 Hospital Bridge Road, Twickenham. These restrictions will be in force between 9am on 23 June 2017 and 9am on 24 June 2017.
- 3. The Order will come into effect at 9am on 23 June 2017 and remain in force until 9am on 24 June 2017.
- 4. An alternative route for vehicles affected by the closure will be available via Cross Deep and Cross Deep Gardens or via Radnor Road and Cross Deep Gardens, and vice versa.
- 5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.
- 6. Nothing in the Order applies to:
 - (a) any vehicle being used in connection with the filming;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
 - (c) emergency service vehicles.
- 7. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY RESTRICTION OF TRAFFIC) (SPECIAL EVENT - FILMING) (HOSPITAL BRIDGE ROAD AND TENNYSON AVENUE, TWICKENHAM) ORDER 2017

Made: 19 June 2017

Comes into operation: 23 June 2017

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the traffic authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads within the Royal Parks of Richmond Park and Bushy Park, (hereinafter referred to as "the borough roads") is satisfied that an event, the particulars of which are given in Article 2 of the following order, should be held on certain parts of the borough roads and that vehicular traffic should be prohibited and parking restricted in order to facilitate filming on the public highway.

NOW THEREFORE the Council in exercise of the powers conferred by Section 16A of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby makes the following Order:

Commencement and citation

 This Order shall come into operation on 23 June 2017 and may be cited as the London Borough of Richmond upon Thames (Temporary Prohibition of Traffic) (Special Event- Filming) (Hospital Bridge Road and Tennyson Avenue, Twickenham) Order 2017 and shall remain in force until 24 June 2017.

The Event and Interpretation

- (1) The event for which this order makes provision is a filming event.
 - (2) In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

"restricted hours" means between 9am on 23 June 2017 and 9am on 24 June 2017 for the waiting restrictions, and between 1pm and 7pm on 23 June 2017 for the road closure.

Prohibition or restriction of vehicular traffic

- During the restricted hours,
 - (a) no person shall permit any vehicle to proceed, in Tennyson Avenue, Twickenham;

- (b) no person shall cause or permit any deuce to wait or stand in Hospital Bridge Road from a point outside the common boundary of Nos 143/145 Hospital Bridge Road to a point outside the northern boundary of No 157 Hospital Bridge Road, Twickenham.
- 4. Nothing in Article 3 of this order shall apply to any vehicle being used in connection with the said event or to any utility vehicle.
- Nothing in this order shall apply:
 - (a) to anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer;
 - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion
- 6. The provisions of this order will only apply during such times when it is necessary or expedient to prohibit or restrict vehicular traffic in the road(s) or length of road(s) specified in Article 3 of this order and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016(b), as amended.

Alteration of position of/or removal of vehicles

7. Where any vehicle is standing in contravention of the provisions of this order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.

Contravention

8. If a vehicle is left during the restricted hours without complying with the requirements of this order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004(c) may then be issued by a civil enforcement officer in accordance with the requirements of the said Act.

Manner of payment of the penalty charge

9. The penalty charge shall be paid to the Council as provided for by Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011(d).
