

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (2)

**Temporary Waiting Restrictions and Suspension of One-Way Working
Strathmore Road, Teddington**

(Ref: 17/156)

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate delivery of temporary accommodation to Strathmore School, they will introduce a waiting restriction and suspension of one-way working in Strathmore Road, Teddington.
2. Whilst the works take place,
 - (a) no person shall cause or permit any vehicle to wait or stand in Strathmore Road, Teddington to such extent as indicated by prescribed traffic signs and cones.
 - (b) the provisions of the London Borough of Richmond upon Thames (Strathmore Road, Teddington) (One-Way Working) Order 2000 (2000/11) shall be suspended, the effect being to permit two way working in Strathmore Road between the western kerb-line of the access road and the junction with Stanley Road.
3. The restrictions will come into force on 27 September 2017. Further details regarding the dates and times of the restrictions are explained in paragraph 5 of this notice.
4. Nothing in this Notice will apply to:
 - (a) any vehicle being used in connection with the execution of the said works;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (c) any vehicle being used for police, fire brigade or ambulance purposes.
5. The temporary restrictions will be introduced by a notice given under Section 14(2) of the Road Traffic Regulation Act 1984, as amended. The notice will come into effect on 27 September 2017 and remain in force between 7am and 6pm on 27 and 28 September 2017
6. Any vehicle waiting in contravention of any restriction imposed by this Notice may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

6. Any vehicle waiting in contravention of any restriction imposed by this Notice may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.
