ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

Temporary Road Closure and Waiting Restrictions Broad Lane Area, Hampton

(Reference 18/003)

- 1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate gas main replacement works, they intend to make a temporary Traffic Order, the effect of which will be to introduce a temporary prohibition of traffic in various streets in the Broad Lane area of Hampton.
- 2. Whilst the works take place, the restrictions detailed in the Schedule to this Notice shall be in force during the periods stated.
- 3. The order will come into effect on 2 January 2018. The works are anticipated to be in progress from 2 January 2018 until 30 September 2018. The provisions of the order will be in force at all times throughout the duration of the works where relevant signs/cones are placed. The order will remain in force for a period of 18 months, to allow for unexpected events and possible remedial works.
- 4. Signed diversions for traffic affected by the closures will be available in adjacent streets.
- 5. It is anticipated that the road closures will be carried out on a rolling basis with local access maintained whenever possible and the prohibitions will apply only during such time and to such extent as indicated by prescribed traffic signs.
- 6. Nothing in the Order applies to:
 - (a) any vehicle being used in connection with the execution of the said works or any public service or utility vehicle;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
 - (c) emergency service vehicles, subject to site conditions at the time of any emergency.
- 7. Any vehicle waiting in contravention of any restriction imposed by the Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

Street (1)	Restriction (2)	Expected Dates of Restriction (3)
Broad Lane, Hampton	Road closures and waiting restrictions between its junctions with Nightingale Road and Cleveland Avenue.	Rolling closures and waiting restrictions from January 2018 until September 2018.
Cleveland Avenue, Hampton	Waiting restrictions - the entire length.	Late January 2018 for approximately 9 weeks.
Falcon Road, Hampton	Waiting restrictions – at its junction with Broad Lane.	Late January 2018 for approximately 9 weeks
Holly Bush Lane, Hampton	Waiting restrictions – at its junction with Cleveland Avenue.	January 2018 for approximately 2 weeks.
Marlingdene Close, Hampton	Waiting restrictions – the entire length.	Early July 2018 for 3 weeks and from the end of August for 4 weeks.
Percy Road, Hampton	Waiting restrictions – at its junction with Broad Lane.	Mid May 2018 for approximately 3 weeks.
The Avenue, Hampton	Waiting restrictions -at its junction with Broad Lane	Early July 2018 for approximately 3 weeks.
