ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14 (1)

Temporary Parking Suspension Elm Bank Gardens, Barnes

(Ref: 18/012)

- The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate building works, they have made a temporary Traffic Order to restrict traffic in Elm Bank Gardens, Barnes.
- Whilst the works take place, no person shall cause or permit any vehicle to wait or stand in in the parking bay located in Elm Bank Gardens, sited across the rear entrance to 26 The Terrace, Barnes.
- 3. The order will come into effect on 20 January 2018 and continues in force the provisions of a Notice made under S14(2) of the Road Traffic Regulation Act 1984. The restrictions will be in force at all times from 20 January 2018 until 10 July 2018. The order will remain in force for a period of 18 months, to allow for unexpected events and possible remedial works.
- 4. Nothing in this Notice will apply to:
 - (a) any vehicle being used in connection with the execution of the said works;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (c) any vehicle being used for police, fire brigade or ambulance purposes.
- 5. The prohibitions will apply only during such time and to such extent as indicated by prescribed traffic signs.
- 6. Any vehicle waiting in contravention of any restriction imposed by the Notice may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14 (2)

Temporary Parking Suspension Elm Bank Gardens, Barnes

(Ref: 18/012)

- The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate building works, they will restrict parking in Elm Bank Gardens, Barnes.
- 2. Whilst the works take place, no person shall cause or permit any vehicle to wait or stand in the parking bay located in Elm Bank Gardens, sited across the rear entrance to 26 The Terrace, Barnes.
- 3. The restrictions will come into force on 15 January 2018. Further details regarding the dates and times of the restrictions are explained in paragraph 5 of this notice.
- 4. Nothing in this Notice will apply to:
 - (a) any vehicle being used in connection with the execution of the said works;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (c) any vehicle being used for police, fire brigade or ambulance purposes.
- 5. The temporary restrictions will be introduced by a notice given under Section 14(2) of the Road Traffic Regulation Act 1984, as amended. The notice will come into effect on 15 January 2018 and remain in force at all times for a period of 5 days, or until the works are completed, whichever is the sooner. Should the works continue beyond this time the Council will introduce an Order made under S14(1) of the said Act to continue in force the provisions of this Notice for up to eighteen months. It is expected the works will be completed on 10 July 2018.
- 6. The prohibitions will apply only during such time and to such extent as indicated by prescribed traffic signs.
- 7. Any vehicle waiting in contravention of any restriction imposed by the Notice may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY PROHIBITION OF TRAFFIC) (ELM BANK GARDENS) ORDER 2018

Made: 18 January 2018

Comes into operation: 25 January 2018

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted in order to facilitate building works (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order: -

Commencement and citation

1. This Order shall come into operation on 25 January 2018 and may be cited as the London Borough of Richmond upon Thames (Temporary Prohibition of Traffic) (Elm Bank Gardens, Barnes) Order 2018 and shall remain in force for 18 months. The works are expected to be in progress from 20 January 2018 until 10 July 2018.

Prohibition or restriction of vehicular traffic

- 2. Whilst the Order remains in force, at all times from 20 January 2018 until 10 July 2018, no person shall cause or permit any vehicle to wait or stand in in the parking bay located in Elm Bank Gardens, sited across the rear entrance to 26 The Terrace, Barnes.
- 3. Nothing in Article 2 of this Order shall apply to any vehicle connected with the execution of the said works or to any public service or utility vehicle.
- 4. Nothing in this Order shall apply: -
 - (a) to anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion, provided that conditions which prevail on site at any one time do not render it unsafe or impossible for such a vehicle or vehicles to use any part of the public highway for the time being.

5. The provisions of this Order will only apply during such times when it is necessary to prohibit or restrict vehicular traffic in that road or length of road and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016(b).

Contravention

6. If a vehicle fails to comply with the provisions of this Order, a contravention shall be deemed to have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004(c) may then be issued by a civil enforcement officer in accordance with the requirements of that Act.

Manner of payment of the penalty charge

7. The penalty charge shall be paid to the Council as set out in Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011(d).

Alteration of position or removal of vehicles

8. Where any vehicle is standing in contravention of the provisions of this Order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may, under the provisions of the Removal and Disposal of Vehicles Regulations 1986(e), as amended, remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle.
