

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

**Temporary Closure of Public Footpath
PRW 235 Linking Chertsey Road and Langhorn Drive,
Twickenham**

(Reference 18/152)

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate a high voltage cable installation, they have made a temporary Traffic Order, the effect of which will be to introduce a temporary closure of Public Right of Way No, 235.
2. Whilst the works take place, no person shall enter or proceed in Public Right of Way No 235 between Chertsey Road (A316) and Langhorn Drive.
3. The order will come into effect on 23 July 2018. The restrictions will be in force at all times from 23 July 2018 until 3 August 2018 and whilst signs/cones are in place. The order will remain in force for a period of 6 months, to allow for unexpected events and possible remedial works.
4. An alternative route for anyone affected by the closure will be available via Langhorn Drive.
5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY CLOSURE OF FOOTPATH) (PUBLIC RIGHT OF WAY No. 235) ORDER 2018

Made: 19 July 2018

Comes into operation: 23 July 2018

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted in order to facilitate a high voltage cable installation (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order: -

Commencement and citation

1. This Order shall come into operation on 23 July 2018 and may be cited as the London Borough of Richmond upon Thames (Temporary Closure of Footpath) (Public Right of Way No. 235) Order 2018 and shall remain in force for a period of six months, or until the works are completed, whichever is the sooner.

Interpretation

2. (1) In this order, the following expressions shall have the meanings hereby assigned to each respectively: -

"The Council" means Council of the London Borough of Richmond upon Thames;

"enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) The Interpretation Act 1978(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Prohibition or restriction of pedestrian traffic

3. (1) At all times, from 23 July 2018 until 3 August 2018, no person shall enter or proceed in Public Right of Way No 235 between Chertsey Road (A316) and Langhorn Drive.
- (2) Nothing in paragraph (1) of this Article shall apply to
- (a) any person engaged in the execution of the said works
 - (b) anything done with the permission or at the direction of a police officer in uniform.
