TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY CLOSURE OF FOOTPATH) (PRW 223 LINKING MARBLE HILL GARDENS AND HARTINGTON ROAD, TWICKENHAM) ORDER 2019

Made: 3 January 2019

Comes into operation: 7 January 2019

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted in order to facilitate improvement works (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order: -

Commencement and citation

1. This Order shall come into operation on 7 January 2019 and may be cited as the London Borough of Richmond upon Thames (Temporary Closure of Footpath) (PRW 223 Linking Marble Hill Gardens and Hartington Road, Twickenham) Order 2019 and shall remain in force for a period of six months, or until the works are completed, whichever is the sooner.

Interpretation

- 2, (1) In this order, the following expressions shall have the meanings hereby assigned to each respectively: -
 - "The Council" means Council of the London Borough of Richmond upon Thames;
 - "enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment:
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

L B RICHMOND UPON THAMES

Prohibition or restriction of pedestrian traffic

- 3. (1) Between 9.30am and 2.30pm, from 7 January 2019, for a period not exceeding 6 months, no person shall enter or proceed in Public Right of Way No 223 between Marble Hill Gardens and Hartington Road.
 - (2) Nothing in paragraph (1) of this Article shall apply to
 - (a) any person engaged in the execution of the said works
 - (b) anything done with the permission or at the direction of a police officer in uniform.
