1. The Council of the London Borough of Richmond upon Thames propose to make the above Orders under section 83(2) of the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the **Revocation Orders** will be to revoke the existing 40 miles per hour speed limit orders currently in force in lengths of Hampton Court Road, Lower Sunbury Road and Upper Sunbury Road, the effect being that these lengths of roads shall become restricted roads for the purposes of Section 81 of the said Act.

THE COUNCIL OF THE LONDON BOROUGH OF RICHMOND UPON THAMES (hereinafter referred to as “the Council”), after giving public notice and consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 81, 83(2) and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a) (hereinafter referred to as “the Act of 1984”), as amended, and all other powers so enabling hereby make the following Order—

1. This Order may be cited as the London Borough of Richmond upon Thames (Borough-wide) (40 mph Speed Limit) (Revocation) Order 201\* and shall come into operation on \*\*\*\* 20\*\*.
2. The following Orders are hereby revoked:-
  - (a) The London Borough of Richmond upon Thames (Hampton Court Road) (40 mph Speed Limit) (Amendment No. 1) Order 2002;
  - (b) The Richmond upon Thames (40 mph Speed Limit) (No. 1) Traffic Order 1981; and
  - (c) The Richmond upon Thames (40 mph Speed Limit) (No. 1) Traffic Order 1978 Revocation Order 2000.
