



ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (1)

**Temporary Footpath Closure
PROW 122, Petersham**

(Reference 20/002)

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that to facilitate a power connection, they have made a temporary Traffic Order, the effect of which will be to introduce a temporary closure of PROW 122.
2. Whilst the works take place, no person shall proceed in PROW 122 between the eastern kerb-line of River Lane and The Petersham Nurseries Tea Room.
3. The order will come into effect on 13 January 2020. The restrictions will be in force at all times from 13 January 2020 until 17 January 2020 and whilst signs/cones are in place. The order will remain in force for a period of 6 months, to allow for unexpected events and possible remedial works.
4. An alternative route for anyone affected by the closure will be available via River Lane, Petersham Road and PROW128.
5. The prohibitions apply only during such time and to such extent as indicated by prescribed traffic signs.
6. Nothing in the Order applies to:
 - (a) any vehicle being used in connection with the execution of the said works or any public service or utility vehicle;
 - (b) anything done with the permission or at the direction of a police officer in uniform or a civil enforcement officer; or
 - (c) any vehicle being used for police, fire brigade or ambulance purposes.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY CLOSURE OF FOOTPATH) (PROW 122) ORDER 2020

Made: 8 January 2020

Comes into operation: 13 January 2020

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, are satisfied that vehicular traffic should be prohibited and car parking restricted in order to facilitate a power connection. (hereinafter referred to as "the works"):

NOW THEREFORE the Council in exercise of the powers conferred by Section 14(1) of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order: -

Commencement and citation

1. This Order shall come into operation on 13 January 2020 and may be cited as the London Borough of Richmond upon Thames (Temporary Closure of Footpath) (PROW 122) Order 2020 and shall remain in force for a period of six months, or until the works are completed, whichever is the sooner.

Interpretation

- 2, (1) In this order, the following expressions shall have the meanings hereby assigned to each respectively: -

"The Council" means Council of the London Borough of Richmond upon Thames;

"enactment" means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by an enactment;

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) The Interpretation Act 1978(c) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Prohibition or restriction of pedestrian traffic

3. (1) Between 13 January 2020 and 17 January 2020 inclusive, no person shall proceed in PROW 122 between the eastern kerb-line of River Lane and The Petersham Nurseries Tea Room.
- (2) Nothing in paragraph (1) of this Article shall apply to
- (a) any person engaged in the execution of the said works
 - (b) anything done with the permission or at the direction of a police officer in uniform.
