

ROAD TRAFFIC REGULATION ACT 1984

THE LONDON BOROUGH OF RICHMOND UPON THAMES (PRESCRIBED ROUTES) (SCHOOL STREETS) (CONSOLIDATION) EXPERIMENTAL ORDER 2020

SCHOOL STREETS – VARIOUS STREETS

(Reference 20/150)

1. The Council of the London Borough of Richmond upon Thames on 4 November 2020 made the above Order under sections 9 and 10 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Order is to make certain modifications to previously made Orders and consolidate the Orders. The school streets shall operate in the roads detailed and at the times specified in the shedule.
3. Copies of the Order which comes into force 9 November 2020, plans showing the location and effect of the Order and the Council's Statement of Reasons for making the Order: -
 - (a) can be inspected, quoting Reference 20/150, at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and
 - (b) may be viewed on the Council's web-site at http://www.richmond.gov.uk/public_notices.
4. In pursuance of section 10(2) of the Road Traffic Regulation Act 1984 the Assistant Director, Traffic and Engineering of the London Borough of Richmond upon Thames, as the specified officer, or some person authorised in that behalf by that officer may, if it appears to that officer or to that person essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the areas through which the roads affected by the Order runs, modify or suspend the Order or any provision thereof.
5. If the provisions of the Order continue in operation for a period of not less than six months, the Council will consider in due course whether the provisions should be reproduced and continued in force indefinitely by means of an Order under section 6 of the said Act of 1984. Persons wishing to object to or support the making of such an Order for the purpose of such reproduction and continuation in force may, within the period of six months referred to above (i.e. by 16 April 2021) send a statement in writing of their objection and the grounds of that objection to the address below.

7. If any person wishes to question the validity of this Order or of any of their provisions on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of the said Act of 1984 or of any instrument made under the said Act of 1984 has not been complied with, that person may, within 6 weeks from the date on which the Order was made, apply for the purpose to the High Court.

TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (PRESCRIBED ROUTES) (SCHOOL STREETS) (CONSOLIDATION) EXPERIMENTAL ORDER 2020

Made: 4 November 2020

Coming into operation: 16 November 2020

The Council of the London Borough of Richmond upon Thames, in exercise of the powers conferred by Sections 9 and 10 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a), as amended, hereinafter referred to as “the Act of 1984” and all other enabling powers hereby make the following Order —

1. This Order shall come into operation on 16 November 2020 and may be cited as the London Borough of Richmond upon Thames (Prescribed Routes) (School Streets) (Consolidation) Experimental Order 2020.
2. (1) In this Order the expression “enactment” means any enactment whether public, general or local and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 (3) The Interpretation Act 1978(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Whilst this Order continues in force, except as provided in Article 6, no person shall cause or permit any vehicle to proceed in a length of street detailed in in column 3 to Schedule 1 to this Order at such times prescribed in column 4 of that Schedule.
4. There was added to Schedule 1 of the London Borough of Richmond upon Thames (Civil Enforcement Area) (Consolidation No. 8) Order 2008(c) items 634(g) and 687(b)(iii) as set out in Schedule 2 to this Order.
5. The London Borough of Richmond upon Thames (Prescribed Routes) (No. 1) Experimental Order 2020, the London Borough of Richmond upon Thames (Prescribed Routes) (No. 2) Experimental Order 2020, the London Borough of Richmond upon Thames (Prescribed Routes) (No. 3) Experimental Order 2020 and London Borough of Richmond upon Thames (Prescribed Routes) (No. 4) Experimental Order 2020 are hereby revoked.

6. Nothing in Article 3 to this Order will apply to: -
- (a) any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion;
 - (b) anything done with the permission or at the direction of a police constable in uniform;
 - (c) Vehicles either displaying a "School Street Permit" or registered on an approved list maintained by the Council;
 - (d) Vehicles displaying a valid disabled persons' "blue badge";
 - (e) Council vehicles and statutory undertakers serving properties within the restricted street;
 - (f) Delivery and postal service vehicles serving properties within the restricted street;
 - (g) Taxis (Hackney Carriage and private hire) serving properties within the restricted street.
 - (h) any person who causes or permits a vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or Section 67 of the Road Traffic Regulation Act 1984.
7. In pursuance of section 10(2) of the Road Traffic Regulation Act 1984 the Assistant Director, Traffic and Engineering of the London Borough of Richmond upon Thames, as the specified officer, or some person authorised in that behalf by that officer may, if it appears to that officer or to that person essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the area through which the road affected by this Order runs, modify or suspend this Order or any provision thereof.



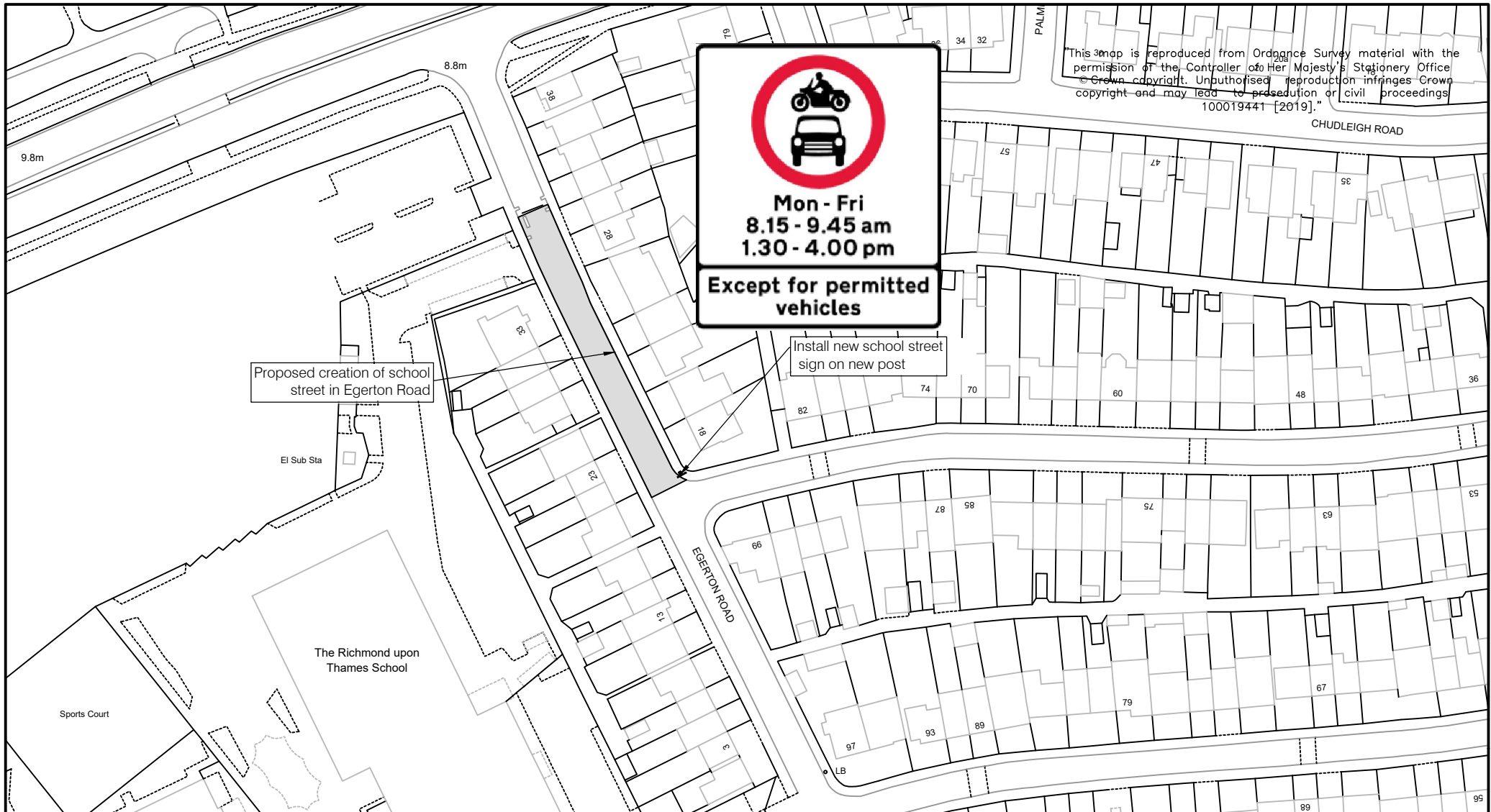
EXPLANATORY NOTE
