

ROAD TRAFFIC REGULATION ACT 1984

THE LONDON BOROUGH OF RICHMOND UPON THAMES (FREE PARKING PLACES)
(LIMITED TIME) (AMENDMENT No. 18) ORDER 2014

MORTLAKE HIGH STREET, MORTLAKE

(Reference 14/021)

1. The Council of the London Borough of Richmond upon Thames on 30 January 2014 made the above Order under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Free Parking Limited Time Order will be to change the operational hours of the existing free parking places limited time in Mortlake High Street, south side, from 117.5 metres east of the eastern kerb-line of Vineyard Path eastwards for a distance of 32 metres, from between 9am and 11am Mondays to Fridays inclusive, to the new operational hours of between 8am and 6.30pm Mondays to Fridays inclusive and between 8am and noon on Saturdays.
3. Copies of the Order, which will come into effect on Monday 10 February 2014, plans showing the location and effect of the orders and the Council's Statement of Reasons for proposing to make the Order:-
 - a. can be inspected, quoting Reference 14/021, at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and
 - b. may be viewed on the Council's web-site at http://www.richmond.gov.uk/public_notices.htm
4. Copies of the Order may be purchased from the Environment Directorate, Civic Centre, 44 York Street, Twickenham, Middx, TW1 3BZ.
5. Persons wishing to question the validity of the Order or any of its provisions on the grounds that it or they are not within the powers conferred by the 1984 Act, or that any requirement of the Act or any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Order was made, apply for the purpose to the High Court.

PARKING PLACES ORDER

Coming into operation: 10 February 2014

The Council of the London Borough of Richmond upon Thames, having consulted the Commissioner of Police of the Metropolis, in exercise of the powers conferred by Sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984(a), as amended, and all other enabling powers hereby make the following Order—

1. This Order shall come into operation on 10 February 2014 and may be cited as the London Borough of Richmond upon Thames (Free Parking Places) (Limited Time) (Amendment No. 18) Order 2014.
2.
 - (1) In this Order the expression “enactment” means any enactment whether public, general or local and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment.
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) The Interpretation Act 1978(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Free Parking Places) (Limited Time) (Consolidation No. 1) Order 2008(c) shall have effect as though there were:-
 - (a) removed in Schedule 11 to that Order the items numbered 11/2; and
 - (b) added to the items in Schedule 12 to that Order the items numbered 12/2 as set out in columns 1, 2, 3, 4 and 5 of the Schedule to this Order

PARKING PLACES IN RESPECT OF WHICH THE MAXIMUM PARKING PERIOD FOR WHICH A VEHICLE MAY BE LEFT DURING THE PERMITTED HOURS IS ONE HOUR.

EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order changes the permitted hours of the free parking places limited time in Mortlake High Street from between 9am and 11am Mondays to Fridays inclusive, to between 8am and 6.30pm Mondays to Fridays inclusive and between 8am and Noon on Saturdays.

STATEMENT OF REASONS

The Council is changing the permitted hours of the free parking places limited time in Mortlake High Street from between 9am and 11am Mondays to Fridays inclusive, to between 8am and 6.30pm Mondays to Fridays inclusive and between 8am and Noon on Saturdays.

The introduction of a change in the permitted hours of the free parking places will encourage short stay parking in Mortlake High Street throughout the day Monday to Friday and on Saturday mornings on Saturdays and are intended to boost trading within the borough.
