
- 1. The Council of the London Borough of Richmond upon Thames on the 27 August 2015 made the above Order under section 16A of the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of this Order is to facilitate the holding of an event in Palmerston Road, East Sheen.
- 3. Whilst the event takes place, no person shall cause or permit any vehicle to enter or proceed in Palmerston Road, East Sheen. The Order will be in force on Monday 31 August 2015 between 10am and 6pm.

TEMPORARY TRAFFIC MANAGEMENT ORDER

THE LONDON BOROUGH OF RICHMOND UPON THAMES (SPECIAL EVENTS) (PALMERSTON ROAD, EAST SHEEN) ORDER 2015

Made: 27 August

Comes into operation: 31 August 2015

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the Highway Authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads in the Royal Parks of Richmond Park and Bushy Park, (hereinafter referred to as "the borough roads") are satisfied that vehicular traffic should be restricted in order that an event may be held in a borough road to facilitate a children's cycle play day:

NOW THEREFORE the Council in exercise of the powers conferred by Section 16A of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby make the following Order:-

Commencement and citation

1. This Order shall come into operation on 31 August 2015 and may be cited as the London Borough of Richmond upon Thames (Special Events) (Palmerston Road, East Sheen) Order 2015 and shall remain in force for one day only.

Interpretation

2 (1) In this order, the following expressions shall have the meanings hereinafter assigned:-

"police community support officer" shall mean a person who has been so designated as such by the Metropolitan Police Service as provided for by section 38 of the Police Reform Act 2002(b) and is wearing an approved uniform as provided for by section 41 of that Act;

"specified day" means Monday 31 August 2015;

"restricted street" means Palmerston Road, East Sheen;

"restricted hours" means between 10am and 6pm;

(2) The Interpretation Act 1978(c) shall apply for the interpretation of this order as it applies to the interpretation of an Act of Parliament.

Prohibition of Traffic

3. Whilst the event takes place, on the specified date, and during the restricted hours, no person shall cause permit any vehicle to enter or proceed in Palmerston Road, East Sheen.

Exemptions

- 4 Nothing in this Order shall apply:-
 - (a) to anything done with the permission or at the direction of a police constable in uniform or a police community support officer; or
 - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion
 - (c) to pedal cycles.

Traffic Signs

5. The provisions of this Order will only apply during such times and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002(d), as amended.
