# THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY RESTRICTION OF TRAFFIC) (HAM CIMMUNITY MARKET) ORDER 2017

#### Richmond Road Richmond

(Reference 17/158)

- 1. The Council of the London Borough of Richmond upon Thames, following the approval of the Secretary of State for Transport, on 18 September 2017 made the above Order under section 16A of the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of this Order is to facilitate the holding of a Community Market in Richmond Road, Ham which is being organised by and is for the benefit of the residents.
- 3. Whilst the market is taking place,
  - (a) no person shall cause or permit any vehicle to proceed in the Richmond Slip Road between its junction with Tudor Drive and Cranmer Court;
  - (b) no person shall cause or permit any vehicle to wait or stand on the parking bays on the western side of Richmond Road, Ham from a point outside the parry wall of Nos 307 and 309 Richmond, northwards to a point outside the party wall of Nos 317 and 319 Richmond Road, Ham.
- 4. Emergency service vehicles will have unrestricted access in the event of an emergency.
- 5. A diversion route for traffic affected by the closure is available via Richmond Road and Upper Ham Road.

## TEMPORARY TRAFFIC MANAGEMENT ORDER

# THE LONDON BOROUGH OF RICHMOND UPON THAMES (TEMPORARY RESTRICTION OF TRAFFIC) (HAM COMMUNITY MARKET) ORDER 2017

Made: 18 September 2017

Comes into operation: 7 October 2017

WHEREAS the Council of the London Borough of Richmond upon Thames (hereinafter referred to as "The Council") being the traffic authority for all streets within the said London borough, with the exception of those streets which are part of the Transport for London Road Network and those which are Crown roads within the Royal Parks of Richmond Park and Bushy Park, (hereinafter referred to as "the borough roads") is satisfied that an event, the particulars of which are given in Article 2 of the following order, should be held on certain of the borough roads and that vehicular traffic should be prohibited and parking restricted in order to facilitate the holding of that event:

AND WHEREAS the Secretary of State for Transport has given his consent to this order insofar as its provisions apply to the specified street on more than one occasion in the same calendar year:

NOW THEREFORE the Council in exercise of the powers conferred by Section 16A of the Road Traffic Regulation Act 1984(a), as amended, and of all other enabling powers hereby makes the following Order:

#### Commencement and citation

1. This Order shall come into operation on 7 October 2017 and may be cited as the London Borough of Richmond upon Thames (Temporary Prohibition of Traffic) (Ham Community Market) Order 2017 and shall remain in force only during the restricted hours on each of the event days.

#### The Event

The event for which this order makes provision is the Ham Community Market.

#### Interpretation

- 3. In this order the following expressions have the meanings herby respectively applied to them:
  - (a) "event days" means the days specified in the schedule to this order;
  - (b) "restricted hours" means between 8am and 3pm;
  - (c) "specified streets" means Richmond Road Slip Road, from its junction with Tudor Drive to its junction with Cranmer Court;

#### Prohibition or restriction of vehicular traffic

- 4. During the restricted hours and on the event days no person may cause any vehicle to:
  - (a) enter or proceed in the specified street; or
  - (b) wait or stand in f the specified street.

## **Exemptions**

- 5. Nothing in Article 4 of this Order shall apply to: any vehicle being used in connection with the said event; or
- Nothing in this Order shall apply:
  - (a) to anything done with the permission or at the direction of a police officer in uniform or a traffic warden; or
  - (b) to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose for which it is being used on that occasion.
- 7. The provisions of this Order will only apply during such times when it is necessary or expedient to prohibit or restrict vehicular traffic in the specified streets to facilitate the event and to such extent as is at the time indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016(b).

#### Alteration of position of/or removal of vehicles

8. Where any vehicle is standing in contravention of the provisions of this Order, a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions or he may remove or cause to be removed the vehicle and, where it is so removed, shall provide for the safe custody of the vehicle

#### Contravention

9. If a vehicle is left during the restricted hours without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable. A penalty charge notice showing the information required by the Traffic Management Act 2004(c) may then be issued by a civil enforcement officer in accordance with the requirements of the said Act.

## Manner of payment of the penalty charge

 The penalty charge shall be paid to the Council as provided for by Schedule 2 to the London Borough of Richmond upon Thames (Manner of Payment of Penalty Charges) Order 2011(d). Dated 18 September 2017

The order provides for the road affected by the market to be closed and for waiting restrictions to apply.
