LONDON BOROUGH OF RICHMOND UPON THAMES  
ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (2)(b)  
**Temporary waiting restrictions, temporary road closure and one-way working**  
**Kew Gardens Road, Kew Green, Kew Road and Lichfield Road**  
**10 to 15 July 2018**

1. The Council of the London Borough of Richmond upon Thames HEREBY GIVES NOTICE that because of the likelihood of danger to the public arising from events in the Royal Botanic Gardens, Kew known as “Kew the Music” they will introduce temporary waiting restrictions in Kew Road, Kew Green and Kew Gardens Road, Kew, a temporary road closure in Lichfield Road, Kew and temporary one-way working in Kew Green, Kew.
2. Whilst the events take place, no person may permit a vehicle:
  - (a) to wait on both sides of Kew Road, from a point 75 metres south-west of its junction with Kew Gardens Road, south-westwards to a point 15 metres south-west of its junction with Pagoda Avenue, or
  - (b) to wait or stand in Kew Road, on its north-western side, from the north-western extremity of the crossing control area outside Victoria Gate, north-eastwards for a distance of 50 metres except for hackney carriages (temporary cab rank), or;
  - (c) to wait on the southern side of the east to west arm of Kew Green; or
  - (d) to wait on the north-eastern side of the north-west to south-east arm of Kew Green, from a point opposite the north-eastern boundary of No 55 Kew Road north-westwards to its junction with Kew Green the east to west arm; or
  - (e) to wait on the western side of Kew Gardens Road from outside No 23 Kew Gardens Road to its junction with Broomfield Road; or
  - (f) to wait on the north-eastern side of Kew Gardens Road from a point outside the south-eastern boundary of Broadlands Court to its junction with Cumberland Road; or
  - (g) to enter or proceed in Lichfield Road; or
  - (h) to proceed in Kew Green, from its junction with the South Circular Road other than in a clockwise direction only.
3. These measures will come into force between 4pm and midnight every day from 10 July to 15 July 2018, these dates being inclusive.
4. An alternative route for traffic affected by the closure is via Kew Gardens Road and Kew Road.
5. Nothing in this notice will apply to anything done with the permission or at the direction of a police officer in uniform, a CEO or an accredited steward.
6. The temporary measures described will be introduced by this notice given under Section 14(2)(b) of the Road Traffic Regulation Act 1984, as amended. The notice will come into effect on 10 July 2018 and will remain in force until 15 July 2018.
7. The prohibitions will apply only during such time and to such extent as indicated by prescribed traffic signs and/or cones.
8. Any vehicle waiting in contravention of any restriction imposed by this notice may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.
