## **ZONE B2 – WHITE HART LANE EXTENSION AND AMENDMENT**

(Reference 23/068)

1. The Council of the London Borough of Richmond upon Thames propose to make the above Orders under sections 6, 45, 46 and 49 of the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the **Parking Places Order** will be to:-
  - (a) Increase the hours of operation of the CPZ in Buxton Road and Fitzgerald Avenue so it operates between 8.30am and 6.30pm on all days of the week;
  - (b) Extend the existing B2 Zone to include Avenue Gardens, Grosvenor Avenue, Grosvenor Gardens, Leconfield Avenue, Sutherland Gardens and Westwood Gardens, the CPZ will operate between 10am and noon on Mondays to Fridays inclusive;
  - (c) to allow both ES and B2 permit holders to park in permit bays located on the south side of South Worple Way, in the vicinity of the Barnes Hospital Site, operating between 10am and Noon on Mondays to Fridays inclusive.
3. The general effect of the **Waiting and Loading Restriction Order** will be to introduce waiting restrictions in various lengths of the roads within the zone.
4. Within the zone, there will be designated permit holder only parking places where only vehicles which display a valid resident's permit, a valid business permit, a residents' visitor permit, a multi-zone business permit or an operational permit may park during the controlled hours.
5. Copies of the proposed Orders, a plan showing the location and effect of the Orders and the Council's Statement of Reasons for making the Orders: -
  - (a) can be inspected, quoting Reference 23/068, at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and
  - (b) may be viewed on the Council's web-site at [http://www.richmond.gov.uk/public\\_notices](http://www.richmond.gov.uk/public_notices).
6. Persons wishing to object to or support the proposals or any part thereof should write to the Head of Engineering, Traffic and Parking Policy, London Borough of Richmond upon Thames, Civic Centre, 44 York Street, Twickenham TW1 3BZ within 28 days of the date of this Notice giving the grounds of their objection. 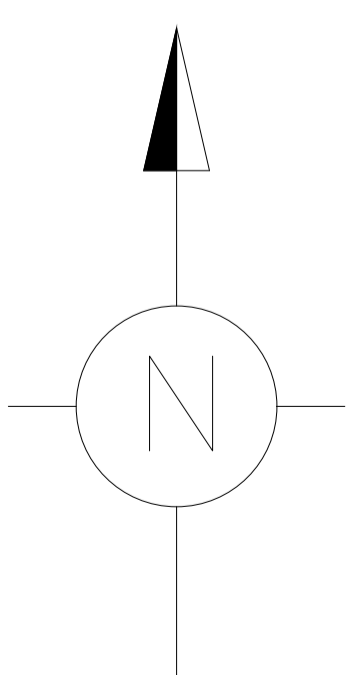
