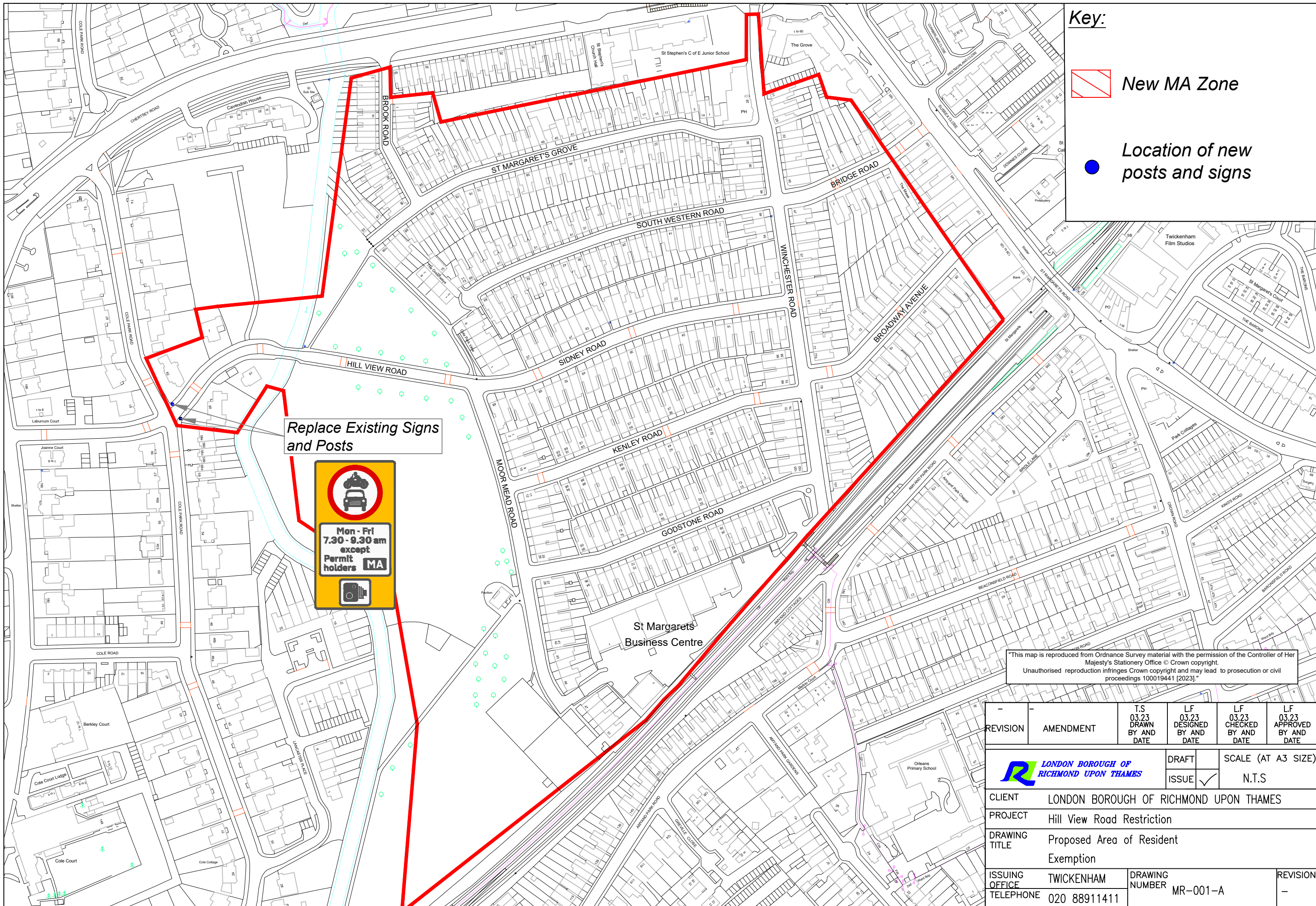
### HILL VIEW ROAD, TWICKENHAM

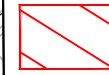
1. The Council of the London Borough of Richmond upon Thames propose to make the above Order under section 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Order will be to introduce an exemption to allow permit holders in certain exempted streets in an area bounded by St Margarets Grove, Winchester Road, Moor Mead Road and the railway line to enter the road closure in Hill View Road, located near the junction of Cole Park Road, between 7.30am and 9.30am on Mondays to Fridays inclusive.
3. Copies of the proposed Order, a plan showing the location and effect of the proposals and the Council's Statement of Reasons for proposing to make the Order: -
  - (a) can be inspected, quoting Reference 23/087, at the Civic Centre (Central Reception, ground floor), 44 York Street, Twickenham between 9.15am and 5pm on Mondays to Fridays, except for Bank and other public holidays; and

4. 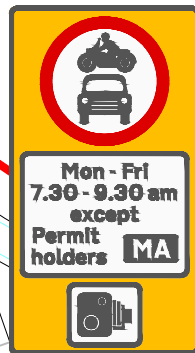


New MA Zone
