CHERTSEY ROAD, DEVON AVENUE, DORSET WAY GLOUCESTER ROAD, HEREFORD GARDENS LINCOLN AVENUE, SELKIRK ROAD, AND WILTSHIRE GARDENS

(Reference 23/093)

- 1. The Council of the London Borough of Richmond upon Thames on 14 June 2023 made the above Order under sections 9 and 10 of the Road Traffic Regulation Act 1984, as amended. The Order will come into force on 26 June 2023.
- 2. The general effect of the Order is to introduce waiting restrictions, operating at any time, and lengths of footway parking, in lengths of Chertsey Road, Devon Avenue, Dorset Way Gloucester Road, Hereford Gardens Lincoln Avenue, Selkirk Road, and Wiltshire Gardens.

In pursuance of section 10(2) of the Road Traffic Regulation Act 1984 the Assistant Director Traffic and Engineering of the London Borough of Richmond upon Thames, as the specified officer, or some person authorised in that behalf by that officer may, if it appears to that officer or to that person essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the areas through which the roads affected by the Order run, modify or suspend the Order or any provision thereof.
- 5. If the provisions of the Order continue in operation for a period of not less than six months, the Council will consider in due course whether the provisions should be reproduced and continued in force indefinitely by means of an Order under section 6 of the said Act of 1984. Persons wishing to object to or support the making of such an Order for the purpose of such reproduction and continuation in force may, within the period of six months referred to above (i.e. 29 December 2023) send a statement in writing of their objection and the grounds of that objection to the address below.

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the London Borough of Richmond upon Thames (Waiting and Loading Restriction) (Civil Enforcement Area) (Consolidation No. 8) Order 2008(c), as amended, shall have effect as though there was added to Schedule 1 to that Order the items set out in columns 1, 2 and 3 of Schedule 1 to this Order.
