- 2. The revised charges for Business Parking Permits are set out in Schedule 1 below together with the existing charges.
- 3. For vehicles which are registered as "Band A" for the purposes of vehicle excise duty, the discounted charge of 50% of the Standard charge currently in place is to be discontinued with effect from 1 July 2025.
- 4. In Central Twickenham (Zone D) and Hampton Wick (Zone X). the Outer Area Business Permit charges are to be discontinued with effect from 1 July 2025.
