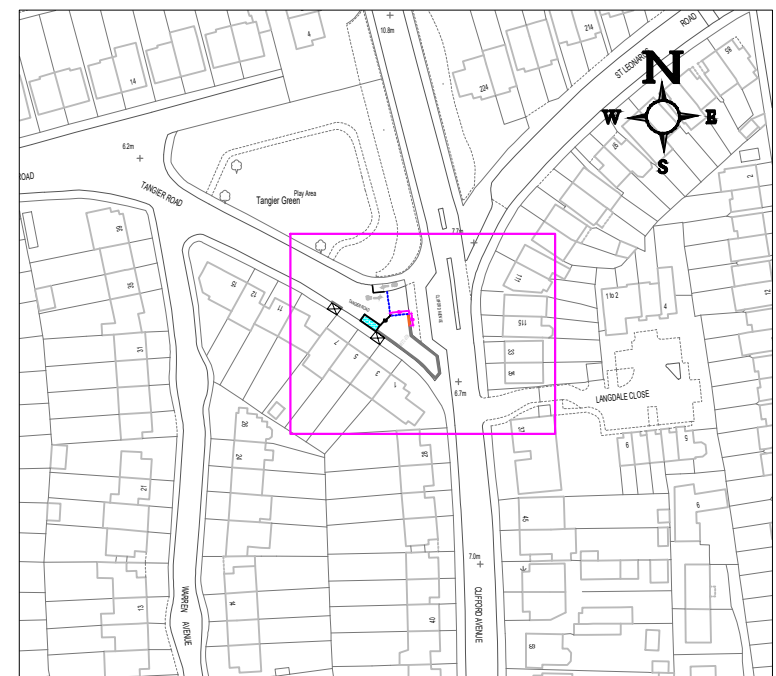
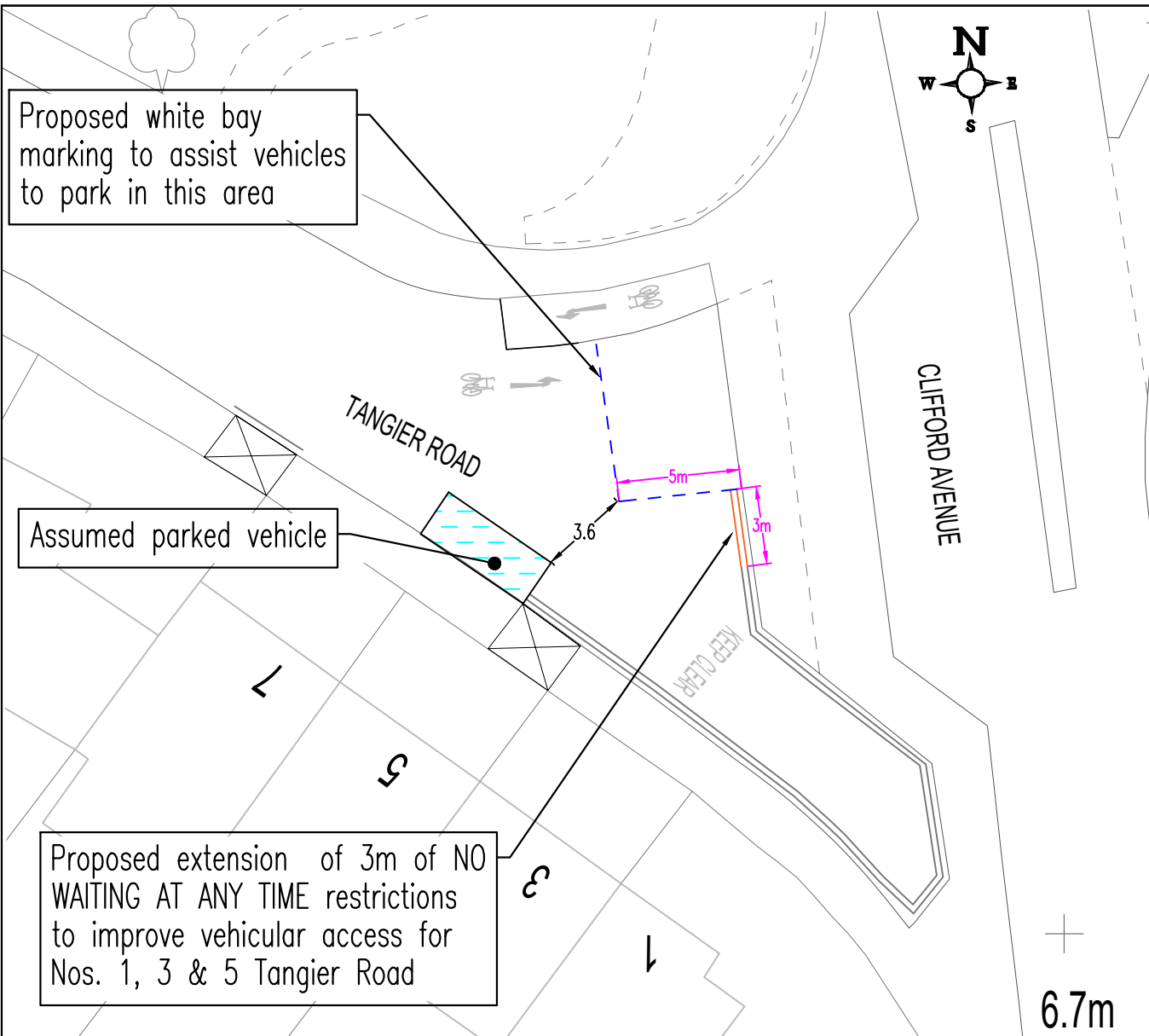

TANGIER ROAD, RICHMOND

1. The Council of the London Borough of Richmond upon Thames propose to make the above Order under section 6, 23 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the **Waiting and Loading Restriction Amendment Order** will to extend by 3M the existing double yellow line restrictions to improve vehicular access for Nos. 1, 3 & 5 Tangier Road.
