#### Appendix 1

### Section 22: Information intended for future publication

Section 22 of the FOIA says that information is exempt if, at the time a public authority receives a request for it:

- The public authority holds it with a view to its publication;
- The public authority or another person intends to publish the information at some future date, whether determined or not; and
- In all the circumstances it is reasonable to withhold the information prior to publication.

Richmond Council confirms that it holds the information and that it is intended for publication on its website.

Richmond Council considers it is reasonable to withhold the statistics prior to publication as this is in accordance with usual practices and information should be disclosed in the same format to maintain a consistent approach.

As we consider the exemption is therefore engaged, we will now explain our decision with regards to the public interest in disclosure.

#### **Public Interest in Disclosure**

Richmond Council acknowledges a generic public interest in transparency.

#### Public Interest in maintaining the exemption

Information Commissioner Decision Notice <u>FS50209662</u> outlines that the balance of the public interest must focus on whether in the circumstances of the case it would be in the public interest for the public authority to keep to its original timetable for disclosure or whether in the circumstances of the case the public interest would warrant an earlier disclosure.

Richmond Council considers it is in the general public interest to disclose the information at the intended time and that there is no specific or pressing public interest in providing the information before the usual date. We consider it would not be in the public interest to prematurely disclose information if to do so may mean it is read out of the context of the overall usual disclosure.

In accordance with the Freedom of Information Act 2000 this letter acts as a partial Refusal Notice
